The first-aid training requirement for shaft and slope employees has been moved to 36 CSR §1-33, which went into effect on March 27, 2021. Since the first-aid training requirements for shaft and slope employees is now contained in 36 CSR §1-33, 56 CSR §11 should be repealed.

- ~~1.1. Scope. -- This rule governs first-aid training for shaft and slope employees.~~
- ~~1.2. Authority. -- W. Va. Code §22A-7-8.~~
- ~~1.3. Filing Date. -- April 22, 1994~~
- ~~1.4. Effective Date. -- May 1, 1994~~
- ~~1.5. Applicability. -- This rule applies to all mine shaft and slope construction and operation sites.~~

~~§56-11-2. Effect of Law and Rule:~~

- ~~2.1. This rule has the effect of law and violations are a violation of law and so cited with the same effect as law.~~

~~§56-11-3. First-Aid Training of Shaft and/or Slope Employees:~~

- ~~3.1. Each employer at a shaft and slope site shall provide every new employee within six (6) months of the date of hire with the opportunity for first-aid training as prescribed by the Director of the Office of Miners' Health, Safety and Training, unless the employee has previously received such training. Each employee is required to take a refresher first-aid training of not less than five (5) hours within each twenty-four (24) months of employment. The employee shall be paid regular wages, and overtime pay if applicable, for all periods of first-aid training.~~
