- 3 ATTORNEY WILSON:
- 4 Good morning. My name is Bob Wilson. I
- 5 am with the Office of the Solicitor, United States
- 6 Department of Labor. With me is Erik Sherer, an
- 7 accident investigator with the Mine Safety and Health
- 8 Administration. Also present are officials with the
- 9 State of West Virginia. I'll ask at this time that
- 10 they state their appearance for the record.
- 11 MR. MCGINLEY:
- 12 Patrick McGinely.
- 13 MR. FARLEY:
- 14 Terry Farley, with the West Virginia
- Office of Miners' Health, Safety and Training.
- 16 MR. O'BRIEN:
- 17 John O'Brien, the Office of Miners'
- 18 Health, Safety and Training.
- 19 ATTORNEY WILSON:
- 20 Today is May 17, 2010. This is an
- interview of Barry Fletcher. Also present in the room
- are several other members of the investigation teams.
- 23 All members of the Mine Safety and Health
- 24 Administration Accident Investigation Team and all
- 25 members of the of the State of West Virginia Accident

- 1 Investigation Team participating in the investigation
- of the Upper Big Branch Mine explosion shall keep
- 3 confidential all information that is gathered from
- 4 each witness who voluntarily provides a statement
- 5 until the witness statements are officially released.
- 6 MSHA and the State of West Virginia shall keep this
- 7 information confidential so that other ongoing
- 8 enforcement activities are not prejudiced or
- 9 jeopardized by a premature release of information.
- 10 This confidentiality requirement shall not preclude
- investigation team members from sharing information
- with each other or with other law enforcement
- officials. Everyone's participation in this interview
- constitutes their agreement to keep this information
- 15 confidential.
- 16 Government investigators and specialists
- 17 have been assigned to investigate the conditions,
- 18 events and circumstances surrounding the fatalities
- that occurred at the Upper Big Branch Mine-South on
- 20 April 5th, 2010. The investigation is being conducted
- 21 by MSHA pursuant to Section 103(a) of the Federal
- 22 Mine, Safety and Health Act and by the West Virginia
- Office of Miners' Health, Safety and Training. We
- appreciate your participation in the investigation.
- 25 After the investigation is complete, MSHA

- 1 will issue a public report detailing the nature and
- 2 the causes of the fatalities in the hope that greater
- 3 awareness about the causes of accidents can reduce
- 4 their occurrence in the future. Information obtained
- 5 through witness interviews is frequently included in
- 6 these reports. You should know that if you request
- 7 confidentiality, confidentiality will only be granted
- 8 on a case-by-case basis. Your statement may also be
- 9 used in other enforcement proceedings as well.
- 10 You may have a personal representative
- 11 present during the taking of the statement and you may
- 12 consult with your representative at any time. Do you
- have a representative with you?
- 14 MR. FLETCHER:
- 15 No.
- 16 ATTORNEY WILSON:
- 17 You may refuse to answer any question and
- 18 you may request a break at any time. This is not an
- 19 adversarial proceeding. Formal Cross Examination is
- 20 not be permitted but clarifying questions are
- 21 appropriate.
- 22 A court reporter will record the
- interviews. Please speak loudly and clearly. If you
- 24 do not understand the question please ask that the
- 25 question be rephrased. Please answer each question as

- fully as you can, including any information that you
- 2 may have obtained from somebody else.
- 3 Again, I would like to thank you in
- 4 advance for your appearance here. We appreciate your
- 5 assistance in this investigation. Your cooperation is
- 6 critical in making the nation's mines safer. After we
- 7 have finished asking questions you will have an
- 8 opportunity to make a statement and provide us with
- 9 any other information that you believe to be
- important.
- 11 If at any time after the interview you
- 12 recall any additional information that you believe may
- be useful, please contact either Terry Farley or
- 14 Norman Page here at the Mine Academy. At this time,
- 15 I'll ask the court reporter to swear you in.

- 17 BARRY FLETCHER, HAVING FIRST BEEN DULY SWORN,
- 18 TESTIFIED AS FOLLOWS:
- 19 -----
- 20 ATTORNEY WILSON:
- 21 I'll turn it over to Attorney Farley.
- 22 EXAMINATION
- BY MR. FARLEY:
- Q. Barry, would you please beginby giving us your
- name, home address and a phone number, please?

- 1 A. Barry C. Fletcher,
- 2
- 3
- 4 Q. How long have you been employed by the West
- 5 Virginia Office of Miners' Health, Safety and
- 6 Training?
- 7 A. Nineteen (19) --- around 19 years. Close to 19.
- 8 Q. How many years in the coal industry did you work
- 9 just prior to that?
- 10 A. Since 1976 I was in the coal industry until I took
- 11 this job.
- 12 Q. So around 35 years now?
- 13 A. Close to it. I was out of the mine about a year
- and a half at one time.
- Q. Which one of the agency's regional offices are you
- 16 based at?
- 17 A. Region 1 out of Westover, West Virginia.
- 18 O. Okay.
- 19 BRIEF INTERRUPTION
- 20 BY MR. FARLEY:
- 21 Q. You work out of our Westover office?
- 22 A. Yes, sir.
- 23 Q. Okay. Are you also a mine rescue team member ---
- 24 A. Yes.
- Q. --- for the agency?

- 1 A. Yes, sir.
- 2 Q. How long have you been a mine rescue team member
- 3 for the agency?
- 4 A. Since '93.
- 5 Q. Okay. Going on 16, 17 years now?
- 6 A. Yes, sir.
- 7 Q. Is that about right? What's your current position
- 8 with the agency?
- 9 A. I'm a roof control inspector out of the Westover
- 10 office, Region 1.
- 11 Q. Now, who do you report to? Who's your main
- 12 supervisor?
- 13 A. Alan Lander.
- Q. Prior to April 5th, 2010, had you ever visited
- what was called Upper Big Branch Mine?
- 16 A. No, I had not.
- 17 Q. Okay. On that date, April 5th of this year, how,
- when and from whom did you learn that a problem
- 19 existed at the Upper Big Branch Mine?
- 20 A. Our mine rescue teams were practicing in the Logan
- area and we were at Chief Logan Lodge, and around four
- 22 o'clock we had returned there and they notified us
- that there had been an incident around four o'clock on
- the 5th, that afternoon.
- Q. When you say they notified us, do you recall who

- 1 might have notified you?
- 2 A. I believe Danny Spratt and Steve Snyder, I believe
- 3 were both there at the time. I'm not sure which one
- 4 of the individuals originally mentioned it.
- 5 Q. Okay.
- 6 A. Danny Spratt did inform the team.
- 7 Q. Okay. Is Danny Spratt the rescue team
- 8 coordinator?
- 9 A. Yes, he is.
- 10 Q. And that was around 4:00 p.m.; you think?
- 11 A. Yes, sir.
- 12 Q. What happened then?
- 13 A. At that point we just assembled our teams and, you
- 14 know, kind of got organized there and then we left for
- the mine, Upper Big Branch Mine.
- Q. And do you recall approximately what time you
- 17 left?
- 18 A. Around 4:15.
- 19 Q. Did you travel directly to the mine?
- 20 A. Yes, sir. Yeah, I was in the mine rescue truck.
- 21 And we traveled from Chief Logan directly to the mine.
- 22 Q. Okay. Can you estimate your approximate time of
- 23 arrival at Upper Big Branch?
- A. Between 5:15 and 5:30. I think it was closer to
- 25 5:30.

- 1 Q. Okay. And at which portal did you arrive?
- 2 A. We first went to the Ellis Portal. At that point,
- 3 we visited our machines and got prepared to work and
- 4 then they informed us to relocate to Montcoal.
- 5 Q. Okay. Do you recall why you had to do that?
- 6 A. That was just the avenue that they chose to get
- 7 into the mine was the Montcoal Portal.
- 8 Q. Okay. What happened then after you --- once you
- 9 went to the Ellis Portal to the Upper Big Branch
- 10 South, what happened then?
- 11 A. Well, we basically went over there and hooked our
- 12 truck up and staged a parity one ground.
- 13 Q. What time did the mine rescue team --- well, what
- 14 time did the first mine rescue team members from
- Office of Miners' Health, Safety and Training enter
- the mine; if you know?
- 17 A. I honestly don't know that answer.
- 18 Q. Okay. What time did you personally enter the mine
- 19 first, approximately?
- 20 Q. When we went underground we went underground as a
- 21 team. I believe we entered the mine around 8:15
- 22 Monday evening.
- 23 Q. Okay. Now, when you say we entered as a team,
- 24 would that have been other team members from the
- Office of Miners' Health, Safety and Training?

- 1 A. Yes, sir. It was two teams from our agency.
- Q. Okay. Do you recall who your other team members
- 3 were?
- 4 A. The North team, yes, sir. Myself, John Hall, Tom
- 5 McGuire, Ralph Tanner, John Scott. How many is that?
- 6 Q. It's four or five.
- 7 A. We had six men. I ---.
- 8 Q. That's okay.
- 9 A. Jeff Bennett was on our team and arrived later.
- 10 We met them later in the day.
- 11 Q. Again, this is not a memory test. It's just ---.
- 12 A. Yeah, I know.
- 13 Q. If you entered the mine about 8:15, did you enter
- the UBB Main South Portal?
- 15 A. If that's the Montcoal Portal.
- 16 Q. Okay. During our interview here and our
- 17 discussion, feel free to use the map at any time.
- 18 A. Okay.
- 19 Q. It might make is much easier for us. And feel
- free to write on it, mark on it, draw lines on
- 21 it, ---
- 22 A. Okay.
- 23 Q. --- whatever it takes to get us to wherever you
- 24 want to take us.
- A. Okay. We have a smaller scale map of the entire

- 1 mine on the board here and we have smaller ones here
- 2 ---
- 3 A. Okay.
- Q. --- for your benefit, so ---.
- 5 MR. SHERER:
- 6 There's a laser pointer if you want to
- 7 use that also.
- 8 BY MR. FARLEY:
- 9 Q. So please just take us through what happened.
- 10 Start from the time you entered the mine. Give me a
- 11 general description of where you went, what you did,
- 12 how it played out.
- 13 A. Well, we were instructed to enter the mine and we
- 14 traveled the Montcoal Portal which was quite a
- 15 distance to the Ellis Switch. And from the Ellis
- Switch we traveled the track in a battery-powered trip
- and we stopped in the area of 76, 77 block of the Four
- 18 North Belt, Five North Belt area. So I think about
- 19 Block 76 was where we stopped. At that point, there
- was supposed to have been a fresh air base there, but
- 21 they had advanced up so when we gathered our men up we
- 22 traveled up to, I think, it was 98 or 99 block to the
- 23 new established fresh air base.
- Q. Okay. Now, when you arrived initially, at 76, ---
- 25 A. Uh-huh (yes).

- 1 Q. --- wherever you were, were you able to travel
- 2 beyond there or were you utilizing a track-mounted
- 3 mantrip?
- 4 A. No, sir. We parked outby that switch and then we
- 5 walked --- we traveled by foot.
- 6 Q. Now, ---.
- 7 A. We were told to stop there. We could have went a
- 8 few breaks further, but obviously, we were told to
- 9 stop, so that's what we did.
- 10 Q. Okay. How much further do you think you could
- 11 have traveled on the track?
- 12 A. Probably about four breaks. About three breaks
- past the switch. There was debris ---
- 14 Q. Okay.
- 15 A. --- in the track.
- 16 Q. Was it just debris or was the track ---
- 17 A. No, it was ---.
- 18 Q. --- damaged?
- 19 A. Things that were forcibly put in the track entry,
- which we assume was by the explosion.
- Q. Okay. So you then had to just travel on foot from
- where you left your mantrip to about 98?
- 23 A. Yes, sir. And we traveled to the new fresh air
- 24 base, and at that time the southern team, which was
- Eugene White and some of his men from that area, they

- 1 wanted to go explore what they call the cut-through
- 2 area. And so they went over there for quite awhile.
- 3 Q. Now, when you say the southern team, now, Eugene
- 4 White works for who?
- 5 A. Miners' Health, Safety and Training .
- 6 Q. Now, when you say the southern team, is that one
- 7 of the industry teams?
- 8 A. No, sir, that's a team from the State of West
- 9 Virginia, Miners' Health, Safety and Training.
- 10 Q. Okay. So that would have been other agency
- 11 employees?
- 12 A. Yes, sir.
- Q. Now, do you recall what time --- approximately
- 14 what time you encountered them?
- 15 A. To the best of my recollection, it was probably
- somewhere around ten o'clock.
- 17 Q. Okay.
- 18 A. It was quite a travel. By the time we drove up
- there and met with the fresh air base, it was around
- 20 10:00 p.m.
- Q. Okay. And this is around crosscut 98?
- 22 A. Yes, sir.
- Q. For the benefit of everyone else, could you
- indicate the location of 98 on the map here, please?
- 25 A. This area right here (indicating). It could have

- 1 been 99, but it was 98 or 99.
- 2 Q. Barry, let me suggest that you take a marker ---
- 3 A. Spad number.
- 4 Q. --- and mark that location and initial beside it
- 5 and indicate fresh air base or whatever it is you're
- 6 trying to describe there.
- 7 A. You mean initial it with this one?
- 8 Q. Sure. That's fine.
- 9 WITNESS COMPLIES
- 10 MR. MCGINLEY:
- 11 So for the record, you wrote FAB for
- fresh air base and your initials ---
- 13 A. Yes, sir.
- 14 MR. MCGINLEY:
- 15 --- at about --- between the ---
- 16 A. 98, 99 block.
- 17 MR. MCGINLEY:
- 18 --- 98 and 99 block?
- 19 A. Yes, sir.
- BY MR. FARLEY:
- 21 Q. Okay. Now, how many teams were at the fresh air
- 22 base at that point?
- 23 A. The best I can recall, it was our two teams.
- 24 There was some individuals there who were manning the
- fresh air base. I believe there were two gentlemen

- 1 there, and I have no idea of their names.
- 2 Q. Okay.
- 3 A. I believe one was a company employee.
- 4 Q. Okay.
- 5 A. He was manning the phone, but ---.
- 6 Q. Okay. All right. How many teams were inby at
- 7 that point; do you know?
- 8 A. I'm not positive on that.
- 9 Q. Okay. I know there were a couple on the
- 10 22 Headgate area that we later encountered, but I
- 11 honestly don't know how many teams were on the ground
- 12 at that point besides our own.
- Q. Okay. So we're up to about 10:00 p.m. now?
- 14 A. Yes, sir.
- Q. Can you pick it up from there and tell us what
- transpired and what you did, please?
- 17 A. Well, I sat here with our team for probably an
- hour or so while they were doing some exploring in
- 19 this area and doing some different things. We had to
- 20 assist them a little bit with radio communication
- 21 because they were spread out. And a couple of our
- guys helped them. Probably an hour or so later we
- began to advance up the track towards 22 Headgate. We
- knew that there was people inby on 22 Headgate based
- on communication with the fresh air base. And our

- 1 goal was to get up there to assist them or to float
- 2 them out if they run out of air. So we advanced, you
- 3 know, sometime after 11:00 --- between 11:00 and
- 4 midnight. We advanced up the track. Of course, there
- 5 was debris, pretty substantial, all the way up through
- 6 there. And we probably went 12 or 15 breaks, and at
- 7 that point myself and John Hall, I made the decision
- 8 to leave our team there and we went up to the 22
- 9 Headgate switch. Just to kind of save everybody
- beating and banging, we went up to the 22 Headgate.
- 11 Q. Can you indicate the 22 Headgate switch on the map
- for us, please?
- 13 A. Well, it would be in this vicinity right here
- 14 (indicating).
- 15 Q. Okay.
- 16 A. This is the track entry and this is the belt
- 17 entry.
- 18 Q. Want to mark it for us, please?
- 19 ATTORNEY WILSON:
- 20 Yeah, why don't you, again, put an
- 21 arrow ---
- 22 A. Sure.
- 23 ATTORNEY WILSON:
- 24 --- and write out here 22.
- A. Now, as we walked up through here, I mean, we had,

- 1 you know, some issues with some air quality. You
- 2 know, it was like a sensation, a burning sensation
- definitely was there at that time as we traveled up
- 4 the track.
- 5 BY MR. FARLEY:
- 6 Q. Now, when you say a burning sensation ---?
- 7 A. In our eyes.
- 8 Q. In your eyes.
- 9 A. Yes, sir.
- 10 Q. Okay.
- 11 A. Now, we had some CO. It was bouncing between 40
- 12 probably in 80 parts per million.
- 13 Q. Okay. You were under apparatus at this point?
- 14 A. Yeah. We eventually went under apparatus about
- 15 halfway up through there. When the numbers started
- increasing, we did put our apparatuses on.
- 17 Q. Okay.
- 18 A. And then the teams stopped here and John Hall and
- 19 I advanced up the track.
- Q. When you say his team stopped here, can you
- 21 communicate approximately where that was?
- A. You know, let's see. Give me a second.
- Q. Take your time.
- A. I'd say in the vicinity of probably 110 block or
- 25 so. Between 110 and 115.

- 1 Q. Okay.
- 2 A. We dropped the team off. Make a note there.
- 3 Q. Just say team waited there.
- 4 A. Okay.
- 5 WITNESS COMPLIES
- 6 BY MR. FARLEY:
- 7 Q. Approximate time?
- 8 A. Yeah, I don't ---. To the best of my
- 9 recollection, about 11:30 or so.
- 10 Q. Okay. That's fine.
- 11 A. But then John Hall and I advanced again up the
- 12 track and we --- I'd say in this vicinity right there
- 13 (indicating). I'll just put stopped.
- 14 Q. Okay.
- 15 ATTORNEY WILSON:
- 16 Where you're indicating stopped, is that
- 17 where the ---
- 18 A. Yeah.
- 19 ATTORNEY WILSON:
- 20 --- switch is there?
- 21 A. Yes, sir. Yeah, the track switch.
- 22 ATTORNEY WILSON:
- 23 Okay. Let's go ahead. I'll mark this
- 24 map as Exhibit Fletcher One.
- 25 (Exhibit Fletcher One marked for

- 1 identification.)
- 2 MR. FARLEY:
- 3 Okay.
- 4 A. So when John and I advanced to the track switch,
- 5 at that point we run into some radio communication
- from the team that was inby us. And I'm not exactly
- 7 sure, but I believe it was the Knox Creek Mine Rescue
- 8 team. I could be mistaken on that, but I believe that
- 9 was the team that was inby.
- 10 BY MR. FARLEY:
- 11 Q. As best you can remember.
- 12 A. And we had a discussion with the radio man, just
- kind of getting a feel for what was going on, and that
- 14 probably took John and I --- I would say, from here to
- here (indicating), I'd say it took us a half hour, 45
- 16 minutes.
- 17 Q. Okay. So a half hour, 45 minutes from where you
- 18 left the rescue team ---
- 19 A. When we ---
- 20 Q. --- to the 22 Headgate switch there?
- 21 A. When we run into the radio guy, probably half an
- hour.
- Q. Okay. So you ran into the radio guy?
- A. Yes, sir. He was dropped off for communication
- 25 purposes near the switch.

- 1 Q. Okay. What did he tell you about what was going
- on inby towards 22 Headgate, if anything?
- 3 A. When we first talked to him, he had said that the
- 4 team was only three by --- I guess, direction of the
- 5 command center, is the way I understood it. And so at
- 6 that point, we waited to make sure that all those men
- 7 made it out and everybody was okay. They didn't need
- 8 any help. And then once that team inby us proceeded
- 9 outby, we also retreated.
- 10 We come back and met up with our guys and then we
- 11 come back to the 99 block, the teams did. And when we
- got to 99 block they were given an instruction to
- retreat from the mine because of some air quality
- 14 readings.
- 15 Q. Okay.
- 16 A. And that was probably around one o'clock ballpark.
- We got outside about 2:30, so I'd say it was about
- 18 right. At that point everybody retreated from the
- 19 mine. All the rescue teams and all the workers, ---
- 20 Q. Okay.
- 21 A. --- which would have been our team and the south
- team.
- Q. So you and John Hall didn't make it any further
- inby than the 22 Headgate switch?
- 25 A. Not on the 5th and 6th. No, sir.

- 1 Q. Okay.
- 2 A. That was the furthest point of our advancement.
- 3 Q. All right. Now, during the evening of the 5th and
- 4 into the morning of 6th, if I followed you correctly,
- 5 you said you traveled the track entry from the fresh
- air base toward the 22 Headgate switch; correct?
- 7 A. That's correct.
- 8 Q. Did you make it into the --- as your belt entry
- 9 there anywhere?
- 10 A. No, sir. We did not make it in the belt entry as
- 11 such. Now, we did look in some crosscuts as the teams
- went up through there, but other than the victim, the
- 13 102, we didn't really notice anything, ---
- 14 Q. Okay.
- 15 A. --- you know, unusual other than just the forces,
- obviously, were there. And debris on the track. But
- no, sir, we did not travel the belt entry. We
- 18 traveled the track entry.
- 19 Q. Okay. Now, as you traveled the track entry, did
- 20 you --- were you able to assess or ascertain the
- 21 direction of the stoppings on either side that might
- have been blown out, or were they blown out?
- 23 A. Yes, sir, there were stoppings damaged and belt
- 24 damage. And to be quiet honest with you, that night
- we were focused on getting to where we thought people

- 1 were at.
- 2 O. Sure.
- 3 A. So yeah, we did see stoppings blown out. We
- 4 didn't map any force directions or anything of that
- 5 nature ---
- 6 Q. Sure.
- 7 A. --- that night.
- 8 O. I understand.
- 9 A. We observed some things, but our goal was to get
- 10 up and assist the inby teams with 22 Headgate
- 11 operation.
- 12 Q. Okay. All right. So you exited the mine after
- midnight, after 1:00 a.m., because you got some ---
- 14 A. The air quality ---
- 15 Q. --- the air quality ---
- 16 A. --- at 22 Headgate.
- 17 Q. --- deteriorated?
- 18 A. Yes, sir.
- 19 Q. What did you do when you got outside?
- A. Well, when we got outside, I mean, as a team, you
- 21 know, we clean the machines and kind of just waited
- for some information, what we were supposed to do. We
- 23 went to our mine rescue truck when we checked out of
- the mine. Went through the normal routine of
- 25 preparing to go back underground as needed.

- 1 Q. Were you involved in a debriefing once you got
- 2 outside?
- 3 A. I cannot remember discussing anything with anyone
- 4 that night or that morning.
- 5 Q. Okay.
- A. Now, I'm not saying that somebody wasn't, but as
- 7 far as our team members, I can speak for myself, I
- 8 really was not debriefed by anybody at the mine.
- 9 Q. Okay. Did you have conversations with Office of
- 10 Miners' Health, Safety and Training supervisors
- 11 personnel when you got outside?
- 12 A. Yes, sir. We discussed, basically, what we run
- into as far as when we put our apparatus on and things
- 14 of that nature, but really no details about any
- particulars of the explosion or forces other than the
- fact that we were curious why we were called outside.
- 17 And then, of course, then we found out when we got to
- 18 the fresh air base we had some bad readings, but ---.
- 19 Q. Okay. After you found out why you were called
- 20 outside, were you satisfied that that was an
- 21 appropriate decision?
- A. I do what they instruct us to do.
- Q. Okay. Now, you're now into the morning of April
- 6th. Were you underground again after that?
- A. No, sir, we were not. We cleaned our truck and

- our machines, and I'm not sure when we left. I
- 2 believe we left Tuesday afternoon or Wednesday to head
- 3 back to Westover ---
- 4 Q. Okay. So you were not ---?
- 5 A. --- regional office.
- 6 Q. Excuse me. You were not involved in the recovery
- 7 operation after that?
- 8 A. Yes, sir, we did return.
- 9 Q. Okay. When did you return?
- 10 A. We returned Friday, the 9th.
- 11 Q. Okay.
- 12 A. And we arrived at the mine about 10:45 Friday
- evening.
- 14 Q. Okay.
- 15 A. On Saturday morning we went underground
- approximately 3:45. That was on the 10th.
- Q. When you say 3:45 on the 10th, is that a.m.
- 18 or ---?
- 19 A. Yes, sir. That's Saturday, the 10th at 3:45.
- 20 Q. Okay. Can you take us through that?
- 21 A. Yeah, at that point we were asked to assist with
- the ventilation of 22 Headgate, meaning our team.
- 23 There was quite a few teams underground at that time
- 24 because the push was on to get onto the 22 Headgate
- 25 section.

- 1 Q. Right.
- 2 A. And so we kind of repeated the routine. The
- 3 Montcoal side traveled a long distance past L switch,
- 4 up four and five belt, and we stopped in the same
- 5 location, I believe that night. They might have
- 6 cleared the track up a couple of blocks, I don't
- 7 recall. But then, obviously, we walked by foot the
- 8 rest of the evening to get where we went.
- 9 Q. Okay. Do you recall where the fresh air base was
- 10 inby 78?
- 11 A. I'm sure that the fresh air base was probably
- 12 still here at 99 block, ---
- 13 Q. Okay.
- 14 A. --- but we never traveled that way. When we got
- up here our goal that night was to assist with the
- 16 accompanying --- of carrying some bodies off the
- 17 headgate section. So we traveled a different
- 18 direction. We traveled up these adjacent entries and
- then across these cut-throughs.
- 20 Q. Okay. Now, those adjacent entries you just
- 21 referred to, can you make those, please, because I
- 22 think ---
- 23 A. Sure.
- Q. --- where you appear to be pointing to are the
- 25 tailgates --- is the tailgate side of the longwall?

- 1 A. Yes, sir. Now, I'm not sure it if was Four, Five
- 2 or Six, but we traveled ---
- 3 Q. Okay.
- A. --- these entries here. And I'm just going to put
- 5 a note here (indicating). I'm just going to put the
- 6 tailgate of the longwall.
- 7 Q. Okay.
- 8 ATTORNEY WILSON:
- 9 Just for the record, what did you write
- 10 down?
- 11 A. Traveled up toward the tailgate of the longwall.
- 12 ATTORNEY WILSON:
- 13 If it's okay with you, ---
- 14 A. Sure.
- 15 ATTORNEY WILSON:
- 16 --- put the date, that's, I think you
- said, 4/10; is that right?
- 18 MR. FARLEY:
- 19 Yeah. Saturday morning.
- 20 ATTORNEY WILSON:
- 21 Put 4/10/10.
- 22 A. Yeah. And this is from my recollection as well.
- I mean, I'm just trying ---.
- 24 BY MR. FARLEY:
- Q. That's fine. That's fine.

- 1 A. Yeah, that was the a.m. our teams traveled up
- 2 here. And our purpose that night was to assist with
- 3 the recovery of individuals they had ready to go in
- 4 headgate section.
- 5 Q. Okay. Now, again, can you take me through how
- 6 your direction --- direction of travel there, please?
- 7 Now, I know where you're starting from.
- 8 A. Yeah, we traveled a couple of these entries up
- 9 through here, and I'm not sure whether it was this one
- 10 (indicating) ---
- 11 Q. Okay.
- 12 A. --- or this one, to be honest with you, but we
- eventually went across here (indicating).
- 14 Q. Okay. Now, you're marking ---.
- 15 A. The travel direction towards the longwall headgate
- 16 area.
- 17 Q. Okay. Now, this mark you just made, would that be
- a couple of crosscuts outby the mouth of the longwall
- 19 panel?
- 20 A. Yes, sir.
- 21 Q. Is that a fair description?
- 22 A. Yes, sir, but I do not remember which head we were
- 23 in.
- 24 Q. Okay.
- 25 A. I just know we traveled up this set of old --- the

- tailgate mains, ---
- 2 Q. Okay.
- 3 A. --- traveled across the cut-through and then we
- 4 traveled up the belt, the longwall belt to continue to
- 5 help with the transporting of bodies.
- Q. Okay. Now, the longwall belt you're referring to
- 7 would that be on the headgate side of the longwall?
- 8 A. Yes, sir. Section belt.
- 9 Q. Okay.
- 10 A. Yeah, we crossed it. We traveled this direction.
- 11 Q. Okay.
- 12 A. This face isn't right.
- 13 Q. All right. The longwall belt that you traveled,
- 14 you're traveling up, you're traveling inby on the
- longwall belt, what was the damage like there?
- 16 A. It was pretty intensive. You know, stuff was tore
- 17 up.
- 18 Q. Can you describe it?
- 19 A. We had a rigid structure that was, you know,
- 20 misplaced and things of that nature.
- 21 Q. When you say misplaced ---?
- 22 A. Out of its ordinary position in the entry.
- Q. Okay. Is it blowing to one side or the other?
- 24 A. I don't really recall that. We had to cross over
- 25 a time or two. I'm not sure.

- 1 Q. Okay. All right.
- 2 A. I don't recall.
- 3 Q. That will be fine. Continue then, just tell me
- 4 what happened.
- 5 A. Well, what I did the rest of that night, if I
- 6 remember right, we just assisted in carrying people.
- 7 They had some bodies stationed down through here and
- 8 we helped with that, and then when we had those bodies
- 9 removed, we carried from here back to here
- 10 (indicating) and had a rubber-tire mantrip that would
- 11 transport them down this set of entries.
- 12 Q. When you say this set of entries, do you mean on
- the tailgate side?
- 14 A. Yes, sir, the tailgate --- the old tailgate mains.
- 15 They would transport --- as we carried the bodies off
- the longwall headgate area, we would carry them across
- this (indicating) and back to this area here, and then
- they would transport them out.
- 19 Q. So it was necessary to carry the bodies?
- 20 A. It was necessary to carry the bodies because you
- could not put them in a ride. That's correct.
- 22 Q. So you had to carry the bodies from the longwall
- 23 face in the outby direction ---
- 24 A. Right.
- 25 Q. --- down the ---?

- 1 A. Right. They had a few people here. They had a
- few bodies in this area here and I don't remember
- 3 exactly where they were at, but they did ---.
- 4 ATTORNEY WILSON:
- 5 When you say here, I need you to explain
- for the record, describe where you're referring to.
- 7 A. I'm not sure I can. I'm not sure I can. I
- 8 remember walking up here (indicating). We went down
- 9 the belt some. We might have even been in an adjacent
- 10 entry a time or two. If you have a location of the
- 11 victims, which I know you do, wherever they found them
- is where they bagged them and that's where we carried
- them from. That's the best I can tell you.
- 14 BY MR. FARLEY:
- 15 Q. Okay.
- 16 A. And I believe there was three or four in this
- area. And then when we finished up with that, the
- gentlemen that were working on the longwall face, I
- 19 walked up and went down the face and helped them bring
- some bodies up. I wasn't involved in the preparing
- for transport, but I helped them bring some bodies up
- the longwall face.
- 23 MR. MCGINLEY:
- 24 When you say this area, can you just mark
- an X there?

- 1 A. No, I can't.
- 2 MR. MCGINLEY:
- 3 I mean as a general --- not as an
- 4 accurate representation.
- 5 A. No, I can't. You mean the area where the bodies
- 6 were at?
- 7 MR. MCGINLEY:
- 8 No, no. Just you said this area, you
- 9 pointed ---.
- 10 A. I believe we traveled this area some and I believe
- 11 we also in this area. I'd have to go back and --- I
- don't know, I can't remember. I wasn't keeping track
- 13 whether it was One, Two or Three.
- 14 MR. MCGINLEY:
- 15 Just generally, that was the area?
- 16 A. Generally is the best I can tell you is these
- 17 entries.
- 18 MR. MCGINLEY:
- 19 That's fine. If you could just mark an X
- there.
- 21 BY MR. FARLEY:
- Q. When you say these entries, you're referring
- 23 to ---?
- A. The headgate belt entry, the adjacent entry and
- possibly the power entry. I'm not sure which entry

- 1 the power was in.
- 2 MR. FARLEY:
- 3 I think for your benefit, Mr. McGinley,
- 4 we do have a map which indicates these exact locations
- 5 of the bodies.
- 6 MR. MCGINLEY:
- 7 No, that wasn't my point. My point was
- 8 just that he's got a big map here and he's describing
- 9 the general areas.
- 10 A. We traveled the headgate areas, the belt entry
- area and the adjacent entries. We were in there a
- 12 couple times. We had to route around some stuff that
- was damaged to get the bodies carried, and I just
- honestly don't remember what entry ---.
- 15 MR. MCGINLEY:
- 16 But this is just for reading the
- 17 transcript ---
- 18 A. Sure.
- 19 MR. MCGINLEY:
- 20 --- to be able to translate what the
- general area would be when you read the transcript.
- 22 If you just put an X there with the understanding that
- this isn't going to be accurate.
- 24 A. Yeah.
- 25 MR. MCGINLEY:

- 1 We just need some general representation.
- 2 A. Traveled belt on adjacent entries.
- 3 MR. MCGINLEY:
- 4 That's great.
- 5 A. Would that be all right?
- 6 MR. MCGINLEY:
- 7 Sure.
- 8 A. And then we did that from the longwall face,
- 9 wherever it was at, all the way down through here. We
- 10 were kind of in and out. I honestly don't remember
- 11 what areas we were in all of the time. I just don't
- 12 remember.
- 13 BY MR. FARLEY:
- 14 Q. Okay. What time did you finish up there on
- 15 Saturday?
- A. I believe we got out of the mine in the p.m.,
- 17 around 1:45.
- 18 Q. Okay.
- 19 A. That would have been on the 10th.
- 20 Q. Okay. Now, after Saturday, April 10th, were you
- in the mine again?
- 22 A. Yes, sir.
- Q. When was that?
- A. Well, Terry, I'm trying to think back. Saturday
- was the day that we retrieved the rest of the people

- off of the 22 Headgate; is that correct?
- 2 Q. Twenty-two (22) Headgate?
- 3 A. Yes. I'm trying to --- again, rough notes. I
- 4 don't remember the date. Whatever date it was, the
- 5 final day I was underground was the day that we was
- 6 with the MSHA people and southern West Virginia men
- 7 got the bodies off 22 Headgate. And I don't recall
- 8 whether that was a Saturday or a Sunday?
- 9 Q. Is it possible it was a couple days later?
- 10 A. Yeah. And I just tried to ---.
- 11 Q. Okay.
- 12 A. The best I can recall.
- Q. If you don't remember, that's fine. Do you
- 14 remember anything specific about that effort to remove
- the bodies from 22 Headgate?
- 16 A. Well, after we restored the ventilation, the
- 17 Federal 2 Team was up there that night, I do remember
- 18 that, Eastern Associated Coal Federal 2 Team.
- 19 Q. When you say we restored the ventilation, were you
- 20 involved in restoring the ventilation ---?
- 21 A. Yes, sir, we assisted with that somewhat, yeah.
- We were broke up with some different teams, our team
- 23 members. We weren't together as a team. But we
- assisted with hanging some curtain and traveling with
- 25 the teams as they go up in there that night, the night

- 1 we recovered the bodies, and I was involved with that.
- 2 Q. Okay. Can you describe what work was done to
- 3 restore ventilation at the 22 Headgate during this?
- 4 A. They hung a single row of curtains between One and
- 5 Two entry of the 22 Headgate where there was damage,
- and we brought air with us behind our backs. I don't
- 7 remember what entry we stopped at. I believe we they
- 8 went inby the mantrip, and I'm not sure of the
- 9 mantrip's location as far as the block.
- 10 Q. Okay.
- 11 A. A block or two. And once the ventilation was
- 12 restored, then they allowed us to, us meaning the
- individuals involved with the body recovery, to begin
- to prepare the victims for transport.
- 15 Q. Okay. Now, when you say the mantrip --- now, you
- don't recall the exact location of the mantrip on 22
- 17 Headgate; correct?
- 18 A. No, sir, I do not. If I had a map in front of me,
- 19 I might be a little closer. I honestly don't remember
- the crosscut.
- 21 Q. Okay. Now, were there bodies in the mantrip?
- 22 A. Yes, sir.
- 23 Q. How many?
- 24 A. There were two on the outby side and there were
- four on the inby side.

- 1 Q. Okay. Was the mantrip damaged?
- 2 A. Yes, sir. The outby canopy on the mantrip was
- 3 laying inby a couple hundred feet. Never measured,
- 4 don't know what distance it took it, but there was a
- 5 canopy laying inby and the outby canopy was off, so we
- 6 assumed that was from the mantrip the men were on.
- 7 The inby canopy was still attached with some damage to
- 8 it.
- 9 Q. How was the inby canopy damaged?
- 10 A. It appeared that the force came down on the top
- 11 right side.
- 12 Q. Now, when you say the top right side, would that
- be the top ride side as you're looking inby?
- 14 A. Yes, sir.
- 15 Q. Okay. Did you find additional bodies inby the
- 16 mantrip?
- 17 A. Yes, sir. We found three individuals inby the
- trip. They were spaced out probably a block, block
- and a half apart. Don't know block locations.
- 20 Wherever they were plotted on the map. There was
- 21 three individuals. Yes, sir.
- 22 Q. Okay. Did you travel to the 22 Headgate faces?
- 23 A. No, sir, we did not. I did not.
- Q. Okay. Did anyone else that you know of?
- 25 A. Not with my group. And I don't know if anyone

- 1 else did with other groups. I don't know.
- 2 Q. Okay. So you don't recall exactly the date of
- 3 your last time there?
- 4 A. Yeah, the dates kind of ran together. The last
- 5 day underground, the day that we retrieved the men off
- 6 the face, off the 22 Headgate section. I don't know
- 7 what day that was.
- 8 Q. All right. Did you assist in carrying the bodies
- 9 from 22 Headgate?
- 10 A. No, sir. Most of our group prepared the bodies to
- 11 transport, so I did not --- I mean, we helped relocate
- 12 a few to move them to an area that men could pick them
- up, but about a block or so outby the trip is the
- 14 furthest that I carried anyone.
- 15 Q. Okay. How far was it necessary for the other
- people to carry the bodies?
- 17 A. They carried them directly outby the manbus about
- one break. We tried to keep them a break outby the
- 19 manbus. They carried them down, and I'm not sure what
- 20 route they took, but I assume they went down 22 track
- and probably crossed over somewhere. Where, I don't
- 22 know. I can't answer that.
- 23 Q. Okay. Where did they ultimately deliver the
- 24 bodies to?
- 25 A. On the sixth north belt track in this area, I

- believe it was probably --- they probably called it 80
- Block, maybe, 79 Block. When they moved a little bit
- of debris off the track, they brought the mantrips up
- 4 about three or four breaks, and there was an opening.
- 5 There was a stopping out there and they traveled
- 6 through the stopping that I located earlier on the 22
- 7 tailgate side. They carried them from there, from the
- 8 section clear down to there, meaning other teams. I
- 9 don't know what teams or who was involved in that, but
- 10 there was quite a few.
- 11 Q. Can you estimate the distance the distance that it
- was necessary to carry the bodies?
- 13 A. No, sir. I've never measured the map. I'd say it
- was probably close to a mile, but I've not measured so
- 15 I can't say.
- Q. That's fine. Now, can you recall the time of day
- 17 when you exited the mine on your last day there?
- A. I made a note, and I'm not sure if it's accurate,
- that we were out of the mine at 1:45 on Saturday.
- Q. Okay. But that was the time before; right?
- 21 A. Yeah, I made a mistake earlier. That's correct.
- We retrieved the bodies, I believe, on the 12th. I'm
- looking at that. We got out at Sunday. Yeah, I
- messed up on my days, and I'll correct that.
- Q. Okay. The 12th would have been Monday, I believe?

- 1 A. Yes, sir. I don't know how to correct that, but I
- 2 --- for the record.
- 3 Q. You just did. You just did.
- A. Yeah. I have a few rough notes, but yeah, I made
- 5 a mistake. Yeah. The 12th was when we advanced back
- 6 in the mine with Task Force One and the MSHA
- 7 inspectors and retrieved the bodies, so all the
- 8 information I said earlier was on the wrong date.
- 9 Q. Okay. Good enough.
- 10 A. And that day --- yeah, we entered the mine at 11
- o'clock on that day, 11:00 a.m. in the morning on
- 12 Monday. That's correct. I'm sorry.
- 13 Q. All right. While you were traveling ---.
- A. Out of the mine at 12:30, Terry, on Tuesday, 4:13.
- 15 Q. Okay.
- 16 A. I apologize.
- 17 Q. No problem. That's cool. Let me back up on a
- 18 couple things.
- 19 A. Sure.
- Q. When you were traveling back and forth from 22
- 21 Headgate section, did you happen to venture into the
- area to the south of there, I think that's called the
- 23 crossover, which goes towards the longwall face?
- 24 A. I don't recall. I believe the night I was in
- 25 there --- and I was only up there one night, I was

- only on the 22 Headgate. It would have been on a
- 2 Monday and Tuesday morning. And we traveled this
- direction. We traveled this direction up to 22
- 4 Headgate switch and then proceeded up the track.
- 5 Q. Okay. Were you in the area known as Eight North?
- 6 A. No, sir, I was not in the Glory Hole area, the
- 7 Eight North area. No, sir, I was not.
- 8 Q. Okay. And this crossover area that I just
- 9 referred to which extends south from where you turn
- off to go to 22 Headgate towards the longwall face,
- 11 you were not in there?
- 12 A. I don't believe so. I'm pretty sure the day
- 13 before that when I messed up on my date when we
- carried the bodies off the headgate, I'm almost sure
- this is where we traveled meaning across the old
- 16 longwall cut-through up the headgate area, and it
- entries probably at that time one and two.
- 18 Q. Okay.
- 19 A. But no, sir, I was never personally ---
- 20 Q. All right.
- 21 A. --- in that area, that I recall.
- 22 Q. Okay. As you were traveling in and out of
- Headgate 22, did you get any sense of the destruction
- and how it might have originated on forces?
- 25 A. No, sir.

- 1 Q. Any thoughts on that?
- 2 A. No, sir. I mean, you could see there was a little
- 3 bit of movement both directions. There was definitely
- 4 some outby force, and at that time it would have
- 5 probably been the return entry, which should have been
- 6 the Number Three entry, I did notice a scoop when I
- 7 looked through a crosscut, a scoop lid, a battery lid
- 8 was forced and jammed up against a scoop. And we only
- 9 advanced up that direction the one day, so if I spoke
- 10 earlier that we was up there, we were not. We were
- just up there the day --- I was up there the day that
- we retrieved the bodies.
- 13 Q. Okay. Now, that would have been the last day you
- were there?
- 15 A. Yes, sir. That would have been the 12th, and then
- 16 a.m. hours of the 13th. But we got out at, like I
- 17 say, at 12:30 on Tuesday the 13th, so I messed up on
- my days.
- 19 Q. As you traveled the 22 Headgate section, as you
- were traveling in the inby direction, did you get any
- 21 sense of how the configuration of the roof bolt
- 22 plates, were they bent or damaged in any particular
- 23 manner?
- A. No. I think I made note, mental note of a couple
- 25 times when I was on the headgate the previous day of

- 1 some directional forces with some R2 plans, which was
- 2 the bigger plates. But I didn't notice a lot that
- 3 night on that section. I really wasn't focusing on
- 4 that. Our goal was to get the individuals prepared
- for transport. So other than the scoop lid, I noticed
- 6 some forces within the stoppings.
- 7 Q. Okay. Have you been back to the Upper Big Branch
- 8 Mine since the 13th?
- 9 A. No, sir.
- 10 Q. Meaning the 13th of April.
- 11 A. No, sir.
- 12 Q. Is there any question or anything that I haven't
- asked you about this rescue and recovery operation,
- any question about any subject, anything you want to
- share with us that you think would be important?
- 16 A. No, sir.
- 17 EXAMINATION
- 18 BY MR. SHERER:
- 19 Q. First of all, Mr. Fletcher, I'd like to thank you
- for participating in this mine rescue and recovery
- 21 effort. I think I can extend that on the behalf of
- MSHA also. Just a few questions. When you arrived at
- 23 the mine at about 5:30 on the 5th, do you know who was
- in charge?
- 25 A. For the operation or for the mine or for the

- 1 agencies?
- 2 Q. For all of the above.
- 3 A. No, sir, I just reported to Danny Spratt at that
- 4 point and he gave us direction on what we're supposed
- 5 to do.
- 6 Q. Okay. Thank you. From your testimony, it sounds
- 7 like there were other teams in the mine when you got
- 8 there; is that correct?
- 9 A. I believe there were. That's correct.
- 10 Q. When you got to the fresh air base at Crosscut 98,
- 11 you mentioned that you thought there were a team or
- two inby at that time; ---
- 13 A. Yes, sir.
- 14 O. --- is that correct?
- 15 A. Yes, sir.
- 16 O. Were there other individuals not associated with
- the team inby at that time?
- 18 A. I can't answer that. I also don't know.
- 19 MR. SHERER:
- 20 Okay. Thank you.
- 21 EXAMINATION
- 22 BY MR. MCGINLEY:
- Q. I noticed that you were refreshing your
- 24 recollection with notes. Are those notes you took
- contemporaneously or ---?

- 1 A. After the event was over, I just sit down and try
- 2 to do a timeline because obviously I could not
- 3 remember, as earlier noted. But I tried after the
- 4 event, I just tried to sit down and get a rough draft.
- 5 That's why I'm saying that everything is approximate
- times and approximate locations, yes, sir.
- 7 Q. About how many pages of notes do you have there?
- A. It would be probably five and a half, six.
- 9 Q. How were you communicating when you first went in
- on the 5th, radio?
- 11 A. When we arrived at the fresh air base, yes, sir,
- radios. Handheld radios, that's correct.
- 13 MR. MCGINLEY:
- 14 That is all.
- 15 ATTORNEY WILSON:
- 16 All right. We're going to go off the
- 17 record for a minute.
- 18 SHORT BREAK TAKEN
- 19 ATTORNEY WILSON:
- 20 All right. We're back on the record.
- 21 While we were off the record, we made some notations
- 22 to the map, which is marked Exhibit Fletcher One.
- 23 First of all, I believe you indicated around the
- 24 longwall area and the headgate on the longwall, you
- indicated that the green arrows are showing the

- direction of travel that you took on 4/10; is that
- 2 correct?
- A. Yes, sir. I'm not sure that's the exact entries,
- 4 but in that area, we traveled that area.
- 5 ATTORNEY WILSON:
- 6 Okay. And then up on 22 Headgate, you
- 7 wrote down 4/12/10 at mantrip and IB for inby bodies
- 8 and your initials, and that was, again, just
- 9 indicating the area where you were on April 12th late
- in the day into the early morning of 4/13; is that
- 11 correct?
- 12 A. That's correct.
- 13 ATTORNEY WILSON:
- 14 Were there any other notations that we
- made on the map?
- 16 A. No, sir, I don't believe.
- 17 ATTORNEY WILSON:
- 18 All right. Any other questions?
- 19 MR. FARLEY:
- 20 I don't think so.
- 21 MR. BECK:
- 22 Thank you, Barry. Thank you very much.
- 23 ATTORNEY WILSON:
- 24 Mr. Fletcher, thank you on behalf of MSHA
- and the Office of Miner's Health, Safety and Training.

- 1 Your cooperation is very important to the
- 2 investigation as we work to determine the cause of the
