- 3 ATTORNEY BABINGTON:
- 4 My name is Matt Babington. Today is May
- 5 25th, 2010. I'm with the Office of the Solicitor,
- 6 United States Department of Labor. With me is Tim
- Watkins, and accident investigator with the Mine
- 8 Safety and Health Administration, an agency of the
- 9 U.S. Department of Labor. Also present are several
- 10 people from the State of West Virginia. I ask that
- 11 they state their appearance for the record.
- 12 MS. SPENCE:
- 13 I'm Beth Spence, with Davitt McAteer's
- independent team.
- 15 ATTORNEY BABINGTON:
- 16 Terry?
- 17 MR. FARLEY:
- 18 Terry Farley, Miner's Health Safety and
- 19 Training.
- 20 MR. KINDER:
- 21 John Kinder, West Virginia Office of
- 22 Miner's Health Safety and Training.
- 23 ATTORNEY BABINGTON:
- 24 There are several members of the
- investigation team also present in the room today.

- Tim Watkins will be conducting the initial
  questioning. All members of the Miner Safety and
- 3 Health Accident Investigation Team, and all members of
- 4 the State of West Virginia Accident Investigation Team
- 5 participating in the investigation of the Upper Big
- 6 Branch Mine explosion shall keep confidential all
- 7 information that is gathered from each witness who
- 8 voluntarily provides a statement until the witness
- 9 statements are officially released. MSHA and the
- 10 State of West Virginia shall keep this information
- 11 confidential, so that other ongoing enforcement
- 12 activities are not prejudiced or jeopardized by a
- 13 premature release of information. This
- 14 confidentiality requirement shall not preclude
- investigation team members from sharing information
- 16 with each other or with other law enforcement
- officials. Your participation in this interview
- constitutes your agreement to keep this information
- 19 confidential.
- 20 Government investigators and specialists
- 21 have been assigned to investigate the conditions,
- 22 events and circumstances surrounding the fatalities
- 23 that occurred at the Upper Big Branch Mine-South, on
- 24 April 5th, 2010. The investigation is being conducted
- by MSHA, under Section 103(a), of the Federal Mine

- 1 Safety and Health Act and the West Virginia Office of
- 2 Miner's Health, Safety and Training. We appreciate
- 3 your assistance in this investigation.
- 4 You may have your personal attorney
- 5 present during the taking of this statement, or
- 6 another personal representative, if MSHA has permitted
- 7 it. You may consult with your attorney or
- 8 representative at any time. Your statement is
- 9 completely voluntarily. You may refuse to answer any
- 10 question. You may terminate your interview at any
- 11 time or request a break at any time. Since this is
- not an adversarial proceeding, formal Cross
- 13 Examination will not be permitted, however your
- 14 personal representative may ask clarifying questions
- as appropriate. So in this case, you can ask
- 16 clarifying questions
- 17 MR. GUNNOE:
- 18 Okay.
- 19 ATTORNEY BABINGTON:
- 20 And for the record, do you have a
- 21 personal representative with you here today?
- 22 MR. GUNNOE:
- 23 No.
- 24 ATTORNEY BABINGTON:
- 25 Thank you. Your identity and the content

- of this conversation will be made public at the
- 2 conclusion of the interview process, and may be
- 3 included in the public report of the accident, unless
- 4 you request that your identity remain confidential or
- 5 your information would otherwise jeopardize a
- 6 potential criminal investigation. Also there may be a
- 7 need to use the information you provide to us, or
- 8 other information we may ask you to provide in the
- 9 future in other investigations into and hearings about
- 10 the explosion. Do you understand or have any
- 11 questions?
- 12 MR. GUNNOE:
- 13 No. No questions.
- 14 ATTORNEY BABINGTON:
- 15 Okay. After the investigation is
- 16 complete, MSHA will issue a public report detailing
- the nature and causes of the fatalities in the hope
- 18 that greater awareness about the causes of accidents
- 19 can reduce their occurrence in the future.
- 20 Information obtained through witness interviews is
- 21 frequently included in these reports.
- 22 The court reporter will record the
- 23 interview. Please speak loudly and clearly. If you
- do not understand a question asked, please ask me to
- 25 rephrase it. Please answer each question as fully as

- 1 you can, including any information you've learned from
- 2 someone else. Also I'll note that if you're referring
- 3 to the map, please be as specific as possible. It's
- 4 easy to get into a habit of saying we started here,
- 5 and then we went over here, but if you could describe
- 6 the actual area, either by the belt or by the headgate
- 7 or tailgate name, we would appreciate it.
- 8 MR. GUNNOE:
- 9 Okay.
- 10 ATTORNEY BABINGTON:
- 11 I'd like to thank you in advance for your
- 12 appearance here. We appreciate your assistance in
- this investigation. Your cooperation is critical in
- making the nation's mines safer.
- 15 After we've finished asking questions,
- 16 you'll have an opportunity to make a statement and
- 17 provide us with any other information that you believe
- 18 to be important. If at any time after the interview
- 19 that you recall any additional information that you
- 20 believe might be useful, please contact Norman Page at
- 21 the information --- at the contact information
- 22 previously provided.
- 23 Now, finally, any statements given by
- 24 miner witnesses to MSHA are considered to be an
- 25 exercise of statutory rights and protected activity

- 1 under Section 105(c) of the Mine Act. If you believe
- any discharge, discrimination or other adverse action
- is taken against you as a result of your cooperation
- 4 with this investigation, you're encouraged to
- 5 immediately contact MSHA, and file a complaint under
- 6 Section 105(c) of the Act. Terry?
- 7 MR. FARLEY:
- 8 Russell, I want also to advise you West
- 9 Virginia State Law, specifically West Virginia Code
- 10 Chapter 22A., Article 1, Section 22 protects miners
- 11 from discrimination. And if you should experience
- what you might think is discrimination as a result of
- doing these interviews with us, I'm going to offer you
- a memo which contains the address of the West Virginia
- Board of Appeals, which hears complaints about such
- matters, along with my phone number and the phone
- 17 number for Bill Tucker, who's also taking the lead on
- this investigation for the State of West Virginia.
- 19 MR. GUNNOE:
- 20 Okay.
- 21 -----
- 22 RUSSELL GUNNOE, HAVING FIRST BEEN DULY SWORN,
- 23 TESTIFIED AS FOLLOWS:

- 25 EXAMINATION

- 1 BY MR. WATKINS:
- Q. Good morning, Russell.
- 3 A. Morning.
- 4 Q. I appreciate you coming in. I got just some
- background question I need to ask you to begin with;
- 6 okay?
- 7 A. Okay.
- Q. Just bear with me here a little bit. Could you
- 9 please state your full name and spell your last name,
- 10 please?
- 11 A. Russell Lee Gunnoe, G-U-N-N-O-E.
- 12 Q. Okay. Russell, what is your address and telephone
- 13 number, please?
- 14 A.
- 15
- 16 Q. Okay. Russell, are you are appearing here today
- 17 voluntarily?
- 18 A. Yes.
- 19 Q. Okay. How many years of mining experience do you
- 20 have, Russell?
- 21 A. Nine, I think.
- Q. Okay. Just give me a brief description of your
- work experience, where you worked at, you know, about
- 24 how long. I mean, just get it close. You don't have
- 25 to ---.

- 1 A. Well, you mean what kind of jobs I've had ---
- Q. Yeah.
- 3 A. --- and where I worked or ---?
- 4 Q. Yeah. What mine you worked at, what job you had
- 5 at that particular mine.
- 6 A. Well, I've been at a lot of different Massey mines
- 7 there on Route 3. I mean, I worked at Marfork and
- 8 Performance. I was on the mine rescue team, and a
- 9 section boss for a short time, about three months. I
- 10 was a fire boss for about a year. And let's see,
- 11 before that I worked at Black Castle surface mine,
- driving a coal truck. And I started as a red hat at
- 13 Elk Run. Worked there a couple months.
- 14 Q. Okay.
- 15 A. That's pretty much all my background.
- 16 Q. Okay. So your nine years, was all that with
- 17 Massey?
- 18 A. Yes.
- 19 Q. All nine years, Massey.
- 20 A. Yes.
- 21 Q. How long at Upper Big Branch? Do you remember
- 22 when you started there?
- 23 A. Yeah. It was a little over a year that I was
- 24 there. It was maybe --- I think I started there in
- 25 February of last year.

- 1 Q. What did you start off doing? What was your first
- 2 job?
- 3 A. Section boss.
- 4 O. Section boss?
- 5 A. Yes.
- 6 Q. On which section?
- 7 A. Three section.
- 8 O. Which ---?
- 9 A. That's the portal section.
- 10 Q. Portal section. Okay. That would be down towards
- 11 the south end of the mine?
- 12 A. Yes.
- 13 Q. Okay. How long did you section boss for?
- 14 A. Two or three months. Three months, I think.
- 15 Q. Okay. At the time of the accident on the 5th,
- 16 April 5th, what was your job title at that time?
- 17 A. Fire boss.
- 18 O. Fire boss?
- 19 A. Yes.
- 20 Q. And how long have you been doing that job?
- 21 A. I think I started fire bossing in May of last
- 22 year. So it was right at a year, ---
- 23 Q. Okay.
- 24 A. --- I quess.
- Q. Okay. So you went from section boss to fire boss?

- 1 A. Yes.
- 2 O. Okay. Do you have certain areas of the mine that
- 3 you were responsible for, as far as for fire bossing?
- 4 A. Yes. I started --- I walked the outby belt. I
- 5 started at the Mother Drive and walked the beltline to
- 6 the Ellis Portal.
- 7 Q. Okay.
- 8 A. That was Six North, Five North, Four North, belt,
- 9 Ellis Five and Ellis Four belt.
- 10 Q. Okay. Did you ever ride or did you have to walk
- 11 at all?
- 12 A. I walked.
- 13 O. You walked?
- 14 A. Uh-huh (yes).
- 15 Q. About how long would it take you to make that
- 16 trip?
- 17 A. About two hours and 15 minutes, usually, you know,
- if I didn't run into something I had to --- you know,
- 19 a gob out or something I had to clean up along the
- 20 way.
- 21 Q. Okay. Well, just kind of walk me through ---
- through that day, if you will, what --- you know, when
- you first get to the mine, what did you do?
- 24 A. The day of the explosion, I didn't --- I didn't
- work there.

- 1 Q. No, just your regular day.
- 2 A. Oh, regular day?
- Q. Regular day, when you showed up at the mine.
- 4 A. Most days I would ride in from the Ellis Portal,
- 5 up to Four North belt head.
- 6 Q. Now, you can --- that's your map. You can mark on
- 7 it, if --- you know, if you want to mark on, you're
- 8 more than welcome to.
- 9 A. I'm sorry. I said the belt head. I rode to the
- 10 belt tail.
- 11 Q. Okay.
- 12 A. Four North belt tail. And there I would just see
- if I needed to do any cleaning there and rock dust
- 14 that belt head.
- 15 Q. What ---? I don't mean to interrupt you. I don't
- 16 want to.
- 17 A. Okay.
- Q. The belt tail, where's --- about where was that
- 19 at?
- 20 A. It was at 41 Break, which is probably up in here
- 21 somewhere (indicating).
- 22 Q. Okay. I think these are numbered. I'm just going
- 23 to help you a little bit.
- 24 A. Yeah.
- Q. On the outside, so 41.

- 1 A. Yeah, it'd be right here.
- 2 O. Why don't you just grab a colored pen and just
- mark tail or head or whatever it was, just so we mark
- 4 it on the map. We have a highlighter there. That can
- 5 make it easier.
- 6 A. Okay. I would ride into 41 Break, which is, like
- 7 I said, Five North belt head, Four North tail.
- 8 Q. Okay.
- 9 A. And that's where I would get out of --- get out of
- 10 the ride at. I would clean that belt head if I needed
- 11 to and rock dust, and just take care of anything there
- that I knew of that needed to be done. When I got
- done there, most ---. Most of the time I would walk
- up the track entry, up to the next belt head up, which
- 15 was Six North belt head, Five North tail.
- 16 Q. Okay.
- 17 A. I walked there and did the same thing. Cleaned up
- 18 any spillage that was at that belt head, cleaned the
- 19 tail up and rock dust that. And then sometimes I
- 20 would catch a ride, but most times I would walk. And
- 21 then I would walk --- once I got finished there, I
- 22 would walk on down to the Mother Drive. Right here.
- 23 Q. Okay.
- 24 A. I'd walk down there to the Mother Drive, clean up
- 25 Six North tail. They had another fire boss that took

- care of the Mother Drive, so I didn't really mess with
- 2 that too much. I cleaned up around that tail. By the
- 3 time I did all these things and walked that, it would
- 4 be close to 12 o'clock, which was time to start your
- 5 fire boss.
- 6 Q. Okay.
- 7 A. When I'd get up here, I'd usually eat my lunch.
- 8 And then I would --- at 12 o'clock I'd start walking
- 9 the beltline to the outside.
- 10 Q. Okay.
- 11 A. During my walk --- I mean, during my fire boss
- walk, anything I saw on the beltline, you know, I'd
- write down. Well, when I came --- as I was walking up
- through there, I would check to see if the evening
- 15 shift fixed whatever I had wrote in the book, and if
- they didn't, I would work on that, you know, maybe a
- timber that needed to be reset or something.
- 18 Something like that, small stuff.
- 19 Q. Okay. Which shift did you work?
- 20 A. Dayshift.
- Q. Dayshift?
- 22 A. Uh-huh (yes).
- Q. So your hours was what? What time did you start,
- 24 what time did you end and all that?
- 25 A. Most of that, it was from 6:00 to 6:00.

- 1 0. 6:00 to 6:00?
- 2 A. Uh-huh (yes). It was a 12-hour shift. Most of
- 3 that time it was. Some --- there towards the end, I
- 4 was on nine-hour shifts, which was 6:00 to 3:00 ---
- 5 6:00 to 4:00.
- 6 Q. Okay. And who did you report to? Who was your
- 7 boss?
- 8 A. Everett Hager, ---
- 9 Q. Everett Hager.
- 10 A. --- superintendent.
- 11 Q. Okay.
- 12 A. Terry Moore was the mine foreman, but I --- most
- of ---. Most of my orders came from Everett Hager.
- 14 Q. Okay. When you found something and put it in the
- book, who usually countersigned the book?
- 16 A. Terry Moore.
- 17 Q. Terry Moore?
- 18 A. Uh-huh (yes).
- 19 Q. So whose responsibility is it to see that the
- things you put in the book gets corrected?
- 21 A. Terry Moore, since he's the one that countersigns
- it, but, you know, like I said, I would check to see
- 23 if the other people had fixed anything I put in. If
- they hadn't, I'd take care of it.
- 25 Q. Uh-huh (yes).

- 1 A. What I could. Anything I couldn't, I made sure
- 2 that Terry and Everett knew about it and they'd get
- 3 somebody on it.
- Q. Uh-huh (yes). So pretty much every day that's the
- 5 routine that you went through?
- 6 A. Yeah. Pretty much every day. I mean, my times on
- 7 the date board were two, three minutes different every
- 8 day, because, you know, you do the same thing every
- 9 day, it's --- you're about the same time.
- 10 Q. Okay.
- 11 A. And like I said, unless I run into something that
- 12 needed immediate attention, I had to spend more time
- there or something.
- 14 Q. Okay. Unless you had to clean up, what, the head
- 15 drives and tail drives?
- 16 A. Uh-huh (yes).
- 17 Q. And that's a regular occurrence that they would
- gob --- I mean, you had spillage or what?
- 19 A. Yeah. I wouldn't call it gobbed out, but it's
- 20 pretty regular that there was a little spillage.
- 21 Q. Okay.
- 22 A. I mean, you get some stuff there around the tail.
- 23 I mean ---.
- Q. About how long would it take you to clean that up?
- 25 A. Most of the time just a few minutes. I mean, five

- 1 minutes tops.
- Q. And you mentioned you rock dusted. Was it --- was
- 3 it by hand, or do you have a machine, or by hand?
- 4 A. I had --- we had trickle dusters at all the belt
- 5 heads. I would fill those up and start them, let them
- 6 ---. I would hand dust a little around the tails and
- 7 stuff like that.
- 8 Q. Okay. You mentioned trickle dusters. What
- 9 sequence were they on? I mean, how often did they ---
- 10 would they run?
- 11 A. They run when I turned 'em on, which was every
- 12 morning. As I came --- as I came in, I started
- the ---. Starting there at 41 Break. There was a
- trickle duster at 40 Break. And the first thing I did
- 15 after I got the --- I would clean the tail there
- first, so I wasn't blowing dust in my face. And then
- 17 I would start that trickle duster. And then I would
- 18 go on up, like I said. And after I cleaned that tail,
- 19 and hand dusted. Start that trickle duster and move
- on up. And then by the time I done my fire boss run,
- 21 you know, it wasn't like it is when you first turn 'em
- on, it was blasting all that dust. It's trickling by
- then.
- Q. Okay. So how long did they run, when you turned
- 25 'em on? Did you turn 'em off when you come back by or

- 1 did you let 'em run?
- 2 A. I let them run until they emptied. Most of the
- 3 time the evening shift guys would turn 'em off,
- 4 because when I come back down, they wasn't empty.
- 5 Evening shift guys would turn 'em off as they came
- 6 back in. And then like I say, I got out at 42 Break,
- 7 so as I --- once I pass that point, when I got here to
- 8 Ellis Switch there was a trickle duster. I would
- 9 start it on my way out, on my fire boss walk. I'd
- 10 start that one, and then also the one that was at
- 11 Ellis Five head. I would start that one on my way
- out. And the evening shift guy would start that up
- when I was on nine-hour shifts. When I was on 12-hour
- shifts, I would walk all the way to the outside, fill
- out my books, and then come back in, and usually work
- 16 around Ellis Five head or here at the Ellis Switch,
- 17 which was Four North head.
- 18 O. Okay.
- 19 A. I would work around there, ---
- 20 Q. Okay.
- 21 A. --- to take up the rest of my day.
- 22 Q. These trickle dusters, how much --- how much dust
- 23 do they hold? How much could you put in 'em?
- A. About six bags.
- Q. Did they seem to do a pretty good job? I mean, on

- 1 the beltline?
- 2 A. Yeah. They done a good job, but --- they done a
- 3 good job there around the belt heads and stuff. They
- 4 had a --- they didn't --- they wouldn't really dust
- 5 down the beltline real well. I mean, once you get
- five or six breaks outby the head, it didn't do any
- 7 good down there, but they had a ---. They had a dust
- 8 crew that came in and dusted the beltlines anyway at
- 9 night. So the belt heads were about --- that was
- 10 really the main thing, for, you know, the trickle
- 11 dusters.
- 12 Q. Okay. You say you had a dust crew come in every
- 13 night, like they dusted the belts every night?
- 14 A. I assume they dusted somewhere every night.
- 15 Q. Okay. But not necessarily the belt?
- 16 A. Not necessarily where I was, no.
- 17 O. Yeah.
- 18 A. Not every beltline every night.
- 19 Q. Okay. I would say that'd be a lot of dust.
- 20 A. Yeah.
- 21 Q. What about the --- was the belt by itself or did
- it have entries adjacent, adjacent to the beltline?
- 23 Do you know what I'm talking about?
- 24 A. No.
- Q. Did it have air courses that was --- or entry that

- 1 was common with the beltline?
- 2 A. Yeah. Yeah. The track entry, and the beltline
- 3 were common and ---. Somewhere --- I think this other
- 4 entry on the other side of the beltline, that was
- 5 common, too.
- 6 Q. Okay.
- 7 A. Across the intake, it came up this North,
- 8 parallel ---. So all these --- the track entry, the
- 9 belt entry and the one to the right side of beltline
- 10 was all common.
- 11 Q. Okay. So the track crew --- or the belt crew you
- mentioned coming in and they would dust. Did they
- come up the track entry or which entry was they
- 14 dusting?
- 15 A. They came up the track entry. It was the track
- 16 nine duster.
- 17 Q. Okay. What about the entry to the far right that
- 18 you mentioned? How was it dusted?
- 19 A. I don't remember. It was fairly well ---. I
- 20 mean, I don't know how ---. I don't how they got the
- 21 dust over there, but most of the time it was in fairly
- 22 good condition.
- 23 Q. So you didn't have a problem with accumulations
- 24 or ---?
- 25 A. No. Wait. Accumulation of coal dust, like I

- said, this --- at 42, or 41 Break, that would
- accumulate. I would get some dust there for a while.
- Q. Uh-huh (yes).
- 4 A. That's why --- that's why that was my place that I
- 5 started. That was my belt head that I had to grease
- 6 and stuff, so ---. That's where I started every day.
- 7 That one, if I didn't keep it dusted, keep that
- 8 trickle duster running every day, it would accumulate
- 9 a little coal dust but, you know, like I said, I tried
- 10 to stay on, tried to keep that duster running every
- 11 day, and --- which mostly took care of ---.
- 12 Q. When you see accumulations, everybody got a little
- 13 bit different opinion of what --- what you put in the
- 14 book, and stuff. It's kind of a hard question. How
- 15 much would it take --- as far as dusting, how thick
- would it have to be before you actually put in the
- 17 book what it needed to be --- keep it clean and
- 18 dusted?
- 19 A. If it don't look white, it needs to be clean and
- 20 dusted.
- 21 Q. Okay. So black at all just means ---?
- 22 A. Yeah. If it's gray, it needs to be dusted.
- 23 Q. Okay.
- 24 A. I mean ---.
- Q. Is that just your call or was there any guidance

- or direction given to you as far as what does or
- 2 doesn't go in the --- needs to be put in the book?
- 3 A. No. I mean, I guess it was my call, because I
- 4 never had ---. Nobody ever told me not to put
- 5 something in the book that I had, and nobody ever told
- 6 me to --- you know, they didn't tell me I was putting
- 7 too much in or I wasn't putting enough in or anything
- 8 like that.
- 9 Q. Okay. How about any methane readings or anything
- 10 like that, that you had along the ---?
- 11 A. On my beltline, I never did find any methane. At
- 12 the Mother Drive, there was a --- on the Sixth North
- belt at 85 Break there was a pump over in the intake.
- 14 Before they done the ventilation change, I would get
- 15 three or four-tenths of methane over there at that
- 16 pump.
- 17 Q. Okay.
- 18 A. But once they changed that ventilation, that
- 19 intake ---. I say chance the ventilation, but I mean
- 20 the fan that they put in at Bandytown.
- 21 Q. Okay.
- 22 A. Once that started, that took care of all that
- 23 methane that was out there. I never found any more
- 24 methane around that pump. But that was the only place
- I would ever find any is at the 85 Break pump on Sixth

- 1 North belt.
- Q. That would have been an electric pump? That was
- 3 an electric pump?
- 4 A. Yeah.
- 5 Q. Okay. Was there any other pump that you --- that
- 6 you examined?
- 7 A. Uh-huh (yes).
- 8 Q. Where are they at?
- 9 A. Got the one at 85 Break. Then there was --- there
- 10 was a couple down the beltline. There was one at 46
- 11 Break, I think. Then there were --- there was one at
- 12 40 Break. There was a ---. At one time there was a
- trash pump, but it was out of service. There was a
- couple --- there was one at 37 Break. There was --- I
- 15 was trying to think what break that ---. There was a
- couple over in here, but I can't remember what break
- they were.
- 0. Over here, you're referring to ---?
- 19 A. Over in the North --- Parallel North Mains.
- 20 Q. Okay.
- 21 A. There was two pumps over there, but I can't
- remember what break numbers they were.
- 23 Q. Okay.
- 24 ATTORNEY BABINGTON:
- 25 Mr. Gunnoe, do you mind marking with this

- green pen the pumps that you've identified thus far?
- 2 A. Okay.
- 3 ATTORNEY BABINGTON:
- 4 And if you could mark with maybe an X and
- 5 label it pump.
- 6 WITNESS COMPLIES
- 7 A. One at 85 Break. They had --- 52 Break, there was
- 8 one. It was ---. Let me see exactly where that set
- 9 at. It's right here. 53 Break pump's what they
- 10 called that. There was one on the beltline, at 46
- 11 Break. I don't remember exactly where the --- what
- 12 break numbers the ones were in the North Mains --- or
- the North Parallel Mains.
- 14 BY MR. WATKINS:
- 15 Q. If you can ---.
- 16 A. I think it was ---. I think it was 38 Break and
- 17 maybe 40.
- 18 ATTORNEY BABINGTON:
- 19 Those are approximate locations, ---
- 20 A. Yeah.
- 21 ATTORNEY BABINGTON:
- 22 --- those last two?
- A. Yeah. Approximately 38 and 40 Break.
- 24 MR. WATKINS:
- 25 That's fine.

- 1 A. --- in the North Parallel Mains, but I can't
- 2 remember exactly where they were. Let's see. A
- 3 little bit more. It's been a long time, so I'm trying
- 4 not to forget anything.
- 5 MR. WATKINS:
- 6 You're doing fine. You're just ---.
- 7 A. There's one on the beltline at 17 Break. One at,
- 8 I think it was 11. It was 11 or 12 Break. There's
- 9 one at track entry --- I think it was right here at
- 10 this curve. 29 Break, I think, is what it was.
- 11 ATTORNEY BABINGTON:
- 12 For the record, could you describe where
- these last two pumps are that you just labeled?
- 14 A. Okay. There's one at --- I think it's 29 Break,
- on Ellis Five belt. There was one at --- I think it
- 16 was 104 Break. They had them numbered for me. It was
- 17 104 Break on Ellis Four belt.
- 18 BY MR. WATKINS:
- 19 O. It's almost to the ---.
- 20 A. It's almost to the punch-out.
- 21 Q. Yeah.
- 22 A. It's right at the --- it's like, two breaks
- 23 underground.
- 24 Q. Okay.
- 25 A. There was one in the intake straight across from

- 1 that one. Right at the punch-out. There was one ---
- one intake around ---. Let's see. I can't remember
- 3 the breaks, where they were at, really, roundabout. I
- don't remember what break. It was in the intake pump,
- 5 thought.
- 6 Q. Okay.
- 7 A. And it was right around that head (indicating). I
- 8 probably forgot one or two, because it seems like
- 9 there was a bunch around this ---.
- 10 Q. Right in that intersection there?
- 11 A. Right. Yeah. Right there at Ellis Four tail and
- 12 Ellis Five head. There was two or three there
- somewhere, but I'm not sure exactly where they were
- located. One of 'em was right --- I don't know, there
- use to be a intake pump but it had been moved out of
- 16 that intake, I think. And it was in this neutral over
- here, just --- it was a 110 pump right there that was
- 18 pumping. Right in there somewhere. I think that's
- 19 all of 'em. I may have missed one.
- Q. That's quite a few pumps.
- 21 A. That's a bunch of pumps.
- Q. Those are all electric --- electric pumps?
- 23 A. Uh-huh (yes).
- Q. No air pumps in any of these?
- 25 A. No, none of these were air pumps. These --- the

- ones I was marked that was in that --- where I
- 2 couldn't remember that was over in the North Parallel
- 3 Mains, ---
- 4 Q. Uh-huh (yes).
- 5 A. --- those pumps plugged into a D box at 36 Break.
- 6 Q. Okay.
- 7 A. And they were locked out most of the time. They
- 8 were --- they stayed locked out, because they only
- 9 needed to be run about one day a week and we'd go over
- and check and then come back and run 'em.
- 11 Q. Okay.
- 12 A. We'd go over and check that area and see if they
- needed to be run. And if they did, we'd come back and
- take the locks off, plug 'em in and run 'em. But they
- 15 stayed locked up most --- most all the time.
- Q. Let's just start from Ellis Portal coming in. The
- one that you had in the intersection?
- 18 A. Uh-huh (yes).
- 19 Q. If those pumps were off, how much water would
- 20 accumulate?
- 21 A. A lot of these pumps would just --- you could run
- 'em one day a week and keep your water down. I mean,
- if they wasn't run, you might get water, I don't know,
- four inches deep, ---
- 25 Q. Uh-huh (yes).

- 1 A. --- four, maybe five inches deep but, most of
- these, I mean, one day a week you could run 'em ---
- 3 O. Uh-huh (yes).
- 4 A. --- and they was all right. The intake, this
- 5 intake pump here, I can't remember what break that was
- 6 at exactly.
- 7 Q. You marked just outby the ---
- 8 A. Yeah.
- 9 O. --- intersection there?
- 10 A. Yeah. It ran, it would fill up. It would get
- water in the escapeway, so we'd try to run that every
- day or every other day. Most of the time it would run
- 13 just about every day.
- 14 Q. Okay. If any of those pumps, say on the intake,
- went down for a day or so, could you tell the
- difference of no air flow on the sections or anything?
- 17 A. No.
- 18 O. No?
- 19 A. No. It didn't have --- it wasn't no water like
- that.
- 21 Q. Okay.
- 22 A. It wasn't affecting the airflow.
- Q. Okay. What about your stopping lines that's going
- 24 up, are they --- how are they maintained? Are they in
- 25 pretty good condition or did you have issues with 'em?

- 1 A. They were in pretty good condition. I mean, I
- 2 didn't have any issues with them. I never had any
- 3 problems with the stopping line or any air ---. Like
- I said, I was on the outby beltline. I mean, ---
- 5 Q. Uh-huh (yes).
- 6 A. --- I had air all the time.
- 7 Q. Okay.
- 8 A. I had lots of air.
- 9 Q. Did you hear the guys on the section ever complain
- 10 about not having --- not having enough air and you had
- 11 to go back and plaster stoppings or anything like
- 12 that?
- 13 A. I stayed busy on the beltline. I've heard them
- complain about air, and I know that it --- it was
- 15 worked on. But I didn't --- I was busy on the
- 16 beltline. I mean, I had three miles of belt to take
- 17 care of. I didn't have time to do a lot of other
- 18 things.
- 19 Q. Just to clarify, when you say you heard them
- 20 complain, do you remember which section or which crew,
- or anything like that complained?
- 22 A. No. I've heard people say, you know, we don't
- 23 have much air or --- and it was mostly --- most of the
- work of them stoppings that I remember was, like I
- 25 said, when they was putting that fan in, doing the

- 1 ventilation changes, getting ready for the longwall.
- 2 And they came --- they come up to the stopping line
- 3 from right here on Four North belt, the left side of
- 4 the track. They went up the stopping line, checking
- 5 every stopping and replastering, or got spray foam,
- 6 they foamed 'em or plastered 'em from ---. I know
- 7 they did it from Ellis Switch up across ---. I
- 8 remember them working on that.
- 9 Q. Do you remember who was working on that?
- 10 A. Jamie Ferguson. He was working on it, I know. He
- 11 was the vice-president at the time. I know he was
- working on it, but I don't know who else. I know he
- had some guys with him, but I don't know who all it
- 14 was.
- Q. I think you told me, but it didn't register with
- me. When did they do that? When was that done?
- 17 A. When they were setting up for the longwall.
- 18 Q. Way back when they first set it up?
- 19 A. Yeah. When they first set that up, they come up
- 20 that stopping line and replastered everything. And
- that's when they bored the hole for the fan. When
- that fan was being set, that's when they --- or it may
- 23 have been right after the fan was set, they done that
- 24 whole stopping line all the way.
- Q. Okay. Do you remember them working on any other

- 1 ventilation changes or making any changes?
- 2 A. I don't know. I've heard 'em talk about
- 3 ventilation changes, but I don't know. I didn't know
- 4 what was going on up there. Like I say, I stopped at
- 5 the Mother Drive, so ---
- 6 Q. Okay.
- 7 A. --- I really don't have any knowledge of what
- 8 happened past that Mother Drive.
- 9 Q. Okay.
- 10 A. A time or two, if the other fire boss was out, I
- would go up to the longwall and walk the longwall
- belt, but, you know, I stopped ---. I just walked the
- beltline. I never was up there too much.
- Q. Do you know when the last time you was up in that
- 15 area?
- 16 A. I was up there ---. No. I don't remember exactly
- 17 when. I'd say maybe a month before the explosion, I
- 18 was up there.
- 19 Q. Okay.
- 20 A. Maybe. I can't really remember exactly how long
- it was. I mean, it's been a long time.
- 22 Q. Yeah. Okay. But the other two miner sections,
- the One Tailgate and Headgate, were you ever on those
- 24 sections?
- 25 A. No. I don't think I was ---. That tailgate was a

- 1 fairly new section. I have never been up there. And
- 2 the headgate, it had been a long --- a really long
- 3 time since I was up there. I know that --- I knew
- 4 where you went over to it, but I never went up to that
- 5 section.
- 6 Q. Okay.
- 7 A. So ---.
- 8 Q. And do you know about where the wall is --- how
- 9 far up the wall in the mine whenever you --- when you
- 10 made that run?
- 11 A. They were --- they were just maybe ---. I can't
- really tell on this map here. They were maybe, I
- don't know, maybe ten or --- ten breaks up above where
- 14 the headgate section belt came.
- 15 O. Okay.
- 16 A. 'Cause they dumped on the same belt there. When I
- was last up there, they were maybe ten breaks from
- 18 that.
- 19 Q. Okay. They didn't go on the wall or on the
- 20 headgate or tailgate of the wall?
- 21 A. I was on the headgate. I got right into the
- 22 headgate. That's where I started coming back at.
- 23 Q. Do you know what the condition was like on the
- headgate when you were there?
- 25 A. It seemed okay to me, but I'm not a ---.

- 1 Q. Plenty of air, nobody complained of air or
- 2 anything?
- 3 A. Plenty of air on the longwall. Had lots of air on
- 4 the longwall, when I was up there.
- 5 Q. Okay. Any water? You're pretty familiar with
- 6 water. You got a lot of pumps in here, so ---.
- 7 A. There was a little water, I mean, there at the
- 8 jacks, but not ---. I mean, it wasn't ---. It wasn't
- 9 even enough I'd really consider it water.
- 10 Q. Okay.
- 11 A. I mean, it was just a little damp.
- 12 Q. I believe if I remember right, earlier on you said
- you might have worked in the mine above these; is that
- 14 correct?
- 15 A. I don't even know for sure which mine's above.
- Oh, Logan's ---. I never worked at Logan's Fort.
- 17 Q. Okay.
- 18 A. That's above the Glory Hole, I know. I've been in
- 19 it, when I was on mine rescue, but I never did work
- there.
- 21 Q. Okay. Are you still on the mine rescue team?
- A. No. I had to give that up.
- 23 MR. WATKINS:
- 24 Okay. Well, before we get too much
- 25 further, I'll let ---. I'm sure these guys have some

- 1 follow-up questions.
- 2 EXAMINATION
- 3 BY MR. FARLEY:
- Q. A couple --- few things, Russell. When did you
- 5 start dayshift?
- 6 A. When I first started fire bossing, I was --- I
- 7 went on dayshift, which was ---. It was about April
- 8 or May of last year.
- 9 Q. Okay. Have you occasionally worked another shift?
- 10 A. No. I was on dayshift the whole time. Straight
- 11 dayshift ever since I started fire bossing.
- 12 Q. No time worked the nightshift?
- 13 A. Uh-uh (no).
- Q. Never did work the evening shift or a midnight
- shift or anything?
- 16 A. No.
- 17 Q. Okay.
- 18 A. Not while I was fire bossing at UBB.
- 19 Q. Okay. Did you work another shift for any ---?
- 20 A. Not --- well, when I first started section
- 21 bossing, we was on swing shift, so I worked evening
- 22 shift some.
- 23 Q. Okay. That would have been last year?
- 24 A. Yeah. That was last June.
- Q. Okay. What was your last shift before the

- 1 explosion?
- 2 A. The 3rd. I worked the Saturday before the
- 3 explosion.
- 4 Q. Okay. Was the mine idle on April 4th?
- 5 A. I don't remember. That was ---. I don't know.
- 6 That was a Sunday. I was off on a Sunday.
- 7 Q. Okay. You were also off on April 5th, too?
- 8 A. Well, I went in to work, and that's when I --- I
- 9 just ---. Saturday, after I got home from work, they
- 10 called me about my knee, my MRI was back, so they put
- 11 me on . I went to work and
- 12 Everett said --- he said, you might as well just go
- home and get that knee better, go down and talk to 'em
- in the safety department, he said because I don't
- really know anything you can do. So I couldn't --- I
- obviously couldn't walk my beltline.
- 17 Q. Okay. And that was on the morning of April 5th?
- 18 A. Right.
- 19 Q. Okay. While you were talking --- while you were
- there on the morning of April 5th, did you overhear
- 21 anything about the longwall being down that morning
- 22 for any reason?
- A. No. No, I don't know anything about that.
- 24 Q. Okay.
- 25 A. The dayshift longwall crew hadn't even went

- 1 underground when I was --- when I was there. I mean
- 2 I was ---.
- 3 Q. Okay. All right. What time were you there on
- 4 April 5th?
- 5 A. I would say it was about 5:00 a.m.
- 6 Q. Okay. What time does the longwall crew generally
- 7 go ---?
- 8 A. Around 6:00.
- 9 Q. Okay.
- 10 A. And, too, I mean, I wouldn't overhear that anyway.
- 11 The longwall had their own room. It was separate, so,
- 12 you know what I mean? Unless they were just really
- cussing loud about it, I wouldn't have heard it.
- 14 Q. Okay. All right. When you would operate the
- duster, at the belt heads and tail, which way was the
- 16 dust usually moving?
- 17 A. Inby.
- 18 O. Okay. In all cases?
- 19 A. Yeah.
- 20 Q. Ever experience it going the opposite direction?
- 21 A. Not since --- it went inby after they put the fan
- 22 at Bandytown.
- Q. Okay. When was that, do you remember?
- A. Before they started the longwall.
- 25 Q. Okay.

- 1 A. It was --- it's been a while.
- Q. Okay. I think that answers my next question, too,
- which was, they put the Bandytown fan in before the
- 4 longwall started; right?
- 5 A. Right.
- 6 Q. And it was about that time or before when you
- 7 indicated you found three-tenths to four-tenths
- 8 percent methane at a pump around 85, on Six North
- 9 belt; is that right?
- 10 A. Right. Eighty-five (85) Beak pump, before the fan
- 11 went on --- went in up there, you would get methane
- there. After the fan, it pulled all that out.
- Q. Okay. Did you ever pre-shift --- do any pre-shift
- examinations anywhere other than the belts?
- 15 A. Yeah. Yeah. Occasionally.
- 16 0. Such as?
- 17 A. Such as Three and Four section, which is the
- 18 portal section and the barrier section on occasion.
- 19 And like I said, the longwall belt on occasion. And
- 20 the beltline for, well --- the beltline for the old
- 21 --- what we call Two section.
- 22 Q. Uh-huh (yes).
- 23 A. There's the beltline for the old Two section
- 24 before they ---.
- 25 Q. Okay.

- 1 ATTORNEY BABINGTON:
- 2 To clarify the number, the old Two
- 3 section at the Tailgate One North?
- 4 A. Yes.
- 5 BY MR. FARLEY:
- 6 Q. All right. Did you ---? There's a construction
- 7 area outby somewhere ---
- 8 A. Yes.
- 9 Q. --- around the Ellis Switch area.
- 10 A. Uh-huh (yes).
- 11 Q. Did you ever work in that area?
- 12 A. Right. Yeah. Right before I fire bossed, I went
- down there one day to --- there wasn't much of
- anything down there. There was a pump. And when I
- was down there, there was a pump down there and a
- 16 scoop charger.
- 17 Q. Okay.
- 18 A. That was the only thing in there when I went down
- 19 there.
- 20 Q. Okay. All right.
- 21 A. They had a guy that --- the boss usually took care
- of that down there, the foreman that was working down
- there.
- Q. Who was that foreman, do you recall?
- 25 A. No. Oh, Marvin Perdue was down there some. He

- 1 set up a lot and stuff.
- 2 O. Was he a --- was he a foreman or was he a crew
- 3 leader?
- 4 A. Crew leader, I guess, is what he was. I really
- 5 don't know if he was a foreman or a crew leader or
- 6 what.
- 7 Q. Okay.
- 8 A. I know --- I know he fire bossed his area.
- 9 Q. Okay. What was usually the difference between the
- 10 foreman and the crew leader? If you know.
- 11 A. I don't really know.
- 12 Q. All right.
- 13 A. I don't really know, I didn't ---. I think just
- the title is the only difference.
- 15 Q. Okay. All right.
- 16 A. I mean, I know Marvin has his papers, he just
- didn't want to be a section foreman, maybe. I don't
- 18 know.
- 19 Q. Okay. All right.
- 20 A. But I know he was the guy in charge.
- 21 EXAMINATION
- BY MS. SPENCE:
- 23 Q. Mr. Gunnoe, do you know of any ventilation changes
- that were made on that last Saturday you worked?
- 25 A. No. I don't know of anything.

- 1 Q. Did you ever hear anybody talk about if you go to
- 2 certain places in the mine, take the air with you,
- 3 because there's none up there?
- 4 A. No.
- 5 Q. Never heard anybody make a comment like that?
- 6 A. No.
- 7 Q. Did Massey have any kind of a stop smoking program
- 8 or any program to keep tobacco out of the mine?
- 9 A. Well, I don't really know about a program to keep
- 10 tobacco out of the mines, but when I started with
- 11 Massey, you had to take a physical. If you couldn't
- pass the breathing test ---. I mean, if you was a
- smoker, you wasn't going to pass it. So they wouldn't
- 14 hire you if you was a known smoker. If they knew you
- 15 smoked, you didn't get a job. You wasn't allowed to
- smoke anywhere on Massey property. So they had a
- 17 pretty strict policy on smoking.
- 18 MS. SPENCE:
- 19 Thank you. That's all.
- 20 RE-EXAMINATION
- 21 BY MR. WATKINS:
- Q. I got a couple of follow-up questions, before we
- take a break here in a minute. You mentioned, I
- 24 guess, when Terry was talking to you about the
- 25 longwall, Russell.

- 1 A. Uh-huh (yes).
- 2 O. You mentioned they had their separate room?
- 3 A. Yeah.
- 4 Q. Do you remember who was in that room?
- 5 A. Jack Roles. He was the longwall coordinator, he
- 6 stayed over there and their maintenance people, Bobby
- 7 Goss. I mean, they had ---. The longwall crew was
- 8 their own bunch. They had their --- their own people
- 9 they answered to. They didn't answer to the same
- 10 people we did, I didn't think. They answered to Jack.
- I don't know who Jack answers to, but --- but the
- longwall guys are different than the other guys. I
- mean, they travel to different mines and they set the
- longwall up. I mean, they're the --- if that thing's
- running good, they're the chosen few. I mean, they
- 16 --- they wasn't in the office with --- the other
- office with us. They had their own office. And to be
- honest with you, I've never been over there.
- 19 Q. Okay.
- 20 A. I wasn't ---.
- Q. Tried to stay away from that one, did you?
- 22 A. Yeah. I didn't want in that mess.
- 23 Q. Okay. You mentioned when you first started, you
- said you rode in to 41?
- 25 A. Uh-huh (yes).

- 1 O. Who did you ride in with?
- 2 A. Just most days the other fire bosses. I mean,
- 3 sometimes I'd catch a ride with the section crew, or
- 4 I'd just catch a ride. Sometimes I didn't catch a
- 5 ride and I walked from the outside but that's a long
- 6 walk, too, both ways. But most of the time it was
- 7 with the other fire bosses, whoever was working then.
- 8 Q. How about the equipment along the --- along the
- 9 track entry coming in? Was there ever any problem
- 10 with those being maintained, the way you could open
- 11 and close 'em easily?
- 12 A. Can you rephrase that question?
- 13 Q. Yeah. Just your doors when you come in, the
- equipment doors when you come in, was there any
- 15 problem with them being maintained?
- 16 A. They opened and closed. They've been hit a few
- times, but you could open 'em. When I say they've
- 18 been hit a few times, they've been hit, they've been
- 19 bent, but when they got to where they were --- they
- 20 wouldn't close and stop the air, they were fixed.
- 21 They maintained them in that sense. But I've heard a
- lot of people fuss and complain about them doors,
- 23 because they were not electric doors. They didn't ---
- they were when they was put in. And after they got
- 25 hit so many times, they disconnected them. And so a

- 1 lot of people would tell you that they think they were
- 2 not maintained because they had to get out and open
- 'em by hand, but if they opened and closed and stop
- 4 air, they work, so ---.
- 5 Q. Did you ever see anyone leave both of 'em open,
- 6 just go through both of 'em, rather than getting out
- 7 and closing one?
- 8 A. No. No. They were pretty good about closing the
- 9 doors. I know they got a violation one time for that,
- 10 but ---. And this is --- I didn't see this happen,
- but a mantrip went through, and they hollered, leave
- them doors open, we're coming behind you, and there's
- about three mantrips ---. There was an inspector in
- one of the mantrips, so ---.
- 15 Q. Pretty bad timing on that.
- 16 A. Yeah. That was bad timing. That's the only issue
- 17 I ever know of them doors being left open. They got
- 18 a ---.
- 19 MR. WATKINS:
- 20 Let's take a small break here and we'll
- 21 come back.
- 22 ATTORNEY BABINGTON:
- 23 Yeah. Off the record.
- 24 SHORT BREAK TAKEN
- 25 BY MR. WATKINS:

- 1 Q. Russell, just got a few questions here, probably
- 2 the same ones ---. Some that you may have answered.
- Where you made an entry into your belt books, what's
- 4 going to be cleaned or dusted, ---
- 5 A. Uh-uh (no).
- 6 Q. --- usually how long would it take before that
- 7 would get corrected? Did it go time after time, day
- 8 after day? About how long would it take before it
- 9 would get corrected?
- 10 A. Well, most of the time it's a pretty quick thing
- 11 getting it fixed. I mean, a day.
- 12 Q. Uh-huh (yes).
- 13 A. But when you look at the books, these beltlines
- are going to say needs dusted, needs dusted, needs
- 15 dusted. That was almost a constant thing because like
- I said, they had a dust crew, but these are big mines.
- 17 And by the time they made their round of that belt,
- where they started needed it again. You know, they
- 19 --- it was constant dusting all the time.
- 20 Q. Were there any areas that say day after day, when
- 21 you went there, that they always had to put something
- in the book for that day, any one area worse than the
- 23 others?
- 24 A. No. No, not really. It was Four belt needed
- 25 dusted, a lot, but like I said, to me if it gets ---

- 1 if it's not white, it needs dusted. And that area
- 2 stayed damp. And you know how damp rock dust
- 3 gets, ---
- Q. Uh-huh (yes).
- 5 A. --- it just ---. I wanted it to be white. So
- 6 Ellis Four belt, it stayed wrote up a lot for needing
- 7 dusted.
- 8 Q. Okay. What about air readings along the --- along
- 9 the belt? Did you have to take any air readings?
- 10 A. Yeah. Not all the time, every now and then I take
- 11 some air readings.
- 12 Q. What would cause you to take an air reading?
- 13 A. Well, they asked me to take some after --- they
- had another ventilation change on a weekend, and they
- had asked me to take some just random air readings up
- 16 this --- up the beltline, to make sure that, you know,
- we still had the right air, we still had good air. So
- 18 I did that. And then from time to time, I mean, I'll
- 19 take some air readings myself, just to know what we
- 20 have. I mean, you always have air under the belts.
- 21 You could always feel the air, but I'm just a curious
- person, sometimes I just want to know how much.
- 23 Q. You mentioned a ventilation change with the air,
- 24 you'd take air readings. Do you know what that
- 25 ventilation change was?

- 1 A. Well, it's been --- it's been a long time. They
- 2 had a --- there was a problem in this area here around
- 3 the --- we refer to that as 78 Break.
- 4 Q. Okay.
- 5 A. It was around there, there was some --- some of
- 6 those doors you were talking about.
- 7 Q. Yeah.
- 8 A. The intake crossed --- right here's where the
- 9 intake crossed, and here's the doors. Where the
- 10 intake or where the beltline air was coming down
- 11 through there, it didn't want to --- it wanted to go
- down and them come back up here, (indicating) then go
- down this way. They needed to get --- it turned from
- one break right here, and come back up there and then
- 15 back down.
- 16 Q. Okay. Could you just maybe clarify that? Just
- 17 mark the way the air went. Could you highlight that
- 18 with a blue highlighter, please?
- 19 WITNESS COMPLIES
- 20 A. So it's the air off the belt, and down to ---.
- 21 BY MR. WATKINS:
- 22 Q. Okay. So just outby the --- just outby the double
- 23 doors?
- A. Just outby that door it wanted to come down toward
- 25 the old Tailgate One North, ---

- 1 Q. Uh-huh (yes).
- 2 A. --- instead of --- instead of going on across and
- 3 --- or on down this way.
- 4 Q. Okay. Down this way meaning up the ---?
- 5 A. North belt.
- 6 Q. Okay.
- 7 A. Instead of going up Six North beltline at one of
- 8 the --- come down toward Tailgate One North.
- 9 Q. Okay.
- 10 A. But like I said, that was a --- that was a problem
- 11 that they had me check the air direction right here to
- 12 make sure what was going because like I said, it was
- like coming away from that door and then down this
- 14 way. And when they seen what direction it was going,
- they wanted me to take an air reading over in --- to
- see what kind of air we had coming up off this
- 17 beltline.
- Q. Do you know about how much air you measured?
- 19 A. It's been a long time. I can't remember now.
- 20 Q. Okay.
- 21 A. But I mean, that was a --- that was a one-time
- 22 problem, and I took the air readings and they got it
- 23 fixed.
- 24 Q. Okay.
- 25 A. It was --- they told me to check it, and I told

- 1 'em it was doing what they thought it was doing. And,
- 2 you know, I was --- it was during my fire boss walk,
- and I went over and checked how much it was. And they
- 4 said that somebody was going to fix it, so I went on
- 5 out. And I don't know what --- who fixed it, but it
- 6 was --- I know it was fixed the next day when I got
- 7 there. They said somebody was on their way to fix it.
- 8 I walked down the beltline, when I got back the next
- 9 day, it was fixed, so ---.
- 10 Q. How was that --- how was the air going the next
- 11 day?
- 12 A. It was --- it was going the right way, coming down
- the beltline. Of course some of it come down this
- way, but most of it's going --- straight down Six
- 15 North belt.
- 16 ATTORNEY BABINGTON:
- 17 Mr. Gunnoe, could you, with that same
- 18 blue highlighter, draw an arrow showing that the air
- 19 was moving towards Tailgate One North?
- 20 WITNESS COMPLIES
- 21 ATTORNEY BABINGTON:
- 22 Thank you.
- 23 BY MR. WATKINS:
- Q. So the next day when you came back, they had it
- 25 going ---?

- 1 A. Yeah. They told me there was somebody on the way
- 2 to fix it. And the next time I was there, it was
- 3 fixed, so ---.
- 4 Q. Okay. So you don't know what they had to do to
- 5 fix it?
- 6 A. No. I don't have any idea.
- 7 Q. Okay. One of the --- one of the areas we haven't
- 8 talked about too much was the AMS system, or the
- 9 sensors.
- 10 OFF RECORD DISCUSSION
- 11 BY MR. WATKINS:
- 12 Q. Do you know where the sensors is located?
- 13 A. No.
- Q. You never had to check the sensors or ---?
- 15 A. No.
- Q. Do you know who maintained those --- that system?
- 17 A. No, I don't --- I really don't know.
- 18 Q. Okay. Do you ever know of 'em going into alarm or
- 19 anything and calling down the --- and go to a certain
- 20 area and check it out because it went into alarm or
- anything?
- 22 A. (Indicates no.)
- 23 ATTORNEY BABINGTON:
- 24 Is that a no?
- 25 A. Yeah, it's a no.

- 1 ATTORNEY BABINGTON:
- 2 Okay.
- 3 RE-EXAMINATION
- 4 BY MR. FARLEY:
- 5 Q. One more. In your job, you're up and down the
- 6 belts all day long?
- 7 A. Uh-huh (yes).
- Q. Is it fair to say there are mine phones along
- 9 these belts?
- 10 A. Yes.
- 11 Q. Okay. Do you routinely hear production reports
- called out from the working sections of the longwall?
- 13 A. Yeah. I wouldn't say I routinely hear 'em, but I
- 14 know that they make 'em.
- 15 Q. Okay. How frequently are the section foreman and
- the longwall foreman required to call out production
- 17 reports during a shift?
- 18 A. I think it's every two hours or something like it.
- 19 I think it's every two hours. Dayshift they call
- 20 like 9:00. I think they call it 9:00 and 1:00 on
- 21 dayshift or 11:00 and 1:00. I think it's 11:00 and
- 22 1:00 on dayshift.
- Q. Okay. If a longwall shearer or a continuous miner
- on one of the sections is down, would the foreman be
- 25 required to call out and notify the superiors

- 1 immediately when that occurred?
- 2 A. I don't --- I don't like the word required. They
- did. They called out all the time. I don't know if
- 4 they were ever told to. I know when I section boss,
- 5 any time I had a piece of equipment down, I called out
- 6 and let 'em know. I was never told I had to do that,
- 7 but --- but I did.
- 8 Q. Okay.
- 9 A. Because that's what everybody I saw --- everybody
- 10 I ever worked for did, too, so ---. It's just common
- 11 practice.
- 12 Q. All right.
- 13 RE-EXAMINATION
- 14 BY MR. WATKINS:
- 15 Q. Your methane detector that you use, what kind was
- 16 it?
- 17 A. Solaris.
- 18 Q. Solaris. Did you charge it when you were --- were
- 19 you responsible for charging it and calibrating it?
- 20 A. Yeah. I had a charger at my house. I take it
- 21 home and charged it every night, and calibrated it
- 22 once a month.
- Q. Okay. Was any record made of that calibration
- 24 whenever you calibrate it?
- 25 A. Yes.

- Q. Did you have a separate book that you ---?
- 2 A. Well, the instrument says --- you know, it would
- 3 say last calibration, but we have a book, too, we kept
- 4 a record of it.
- 5 Q. Now a couple more questions on the trickle duster.
- 6 I know that you said that you turned 'em on ---
- 7 A. Uh-huh (yes).
- 8 Q. --- and turned 'em off. Did other shifts also?
- 9 Did the other guys do it, too, do you know, or were
- 10 you the only one that turned 'em off?
- 11 A. Most of the time I was the only one. Sometimes I
- 12 would turn 'em --- a couple of 'em on, but I ran --- I
- ran 'em all every day.
- 14 Q. Uh-huh (yes).
- 15 A. And I guess if they saw something that they
- thought needed to have dust, they would turn those on,
- but they didn't run all of 'em every day.
- 18 Q. Okay. And just so I have 'em on the map, I know
- 19 you went over 'em when you were ---. Can you just
- 20 mark ---. Get the red pen and everything and mark
- those where they're at.
- 22 WITNESS COMPLIES
- 23 ATTORNEY BABINGTON:
- 24 Mr. Gunnoe, could you also describe where
- 25 you're marking them as your marking them, please?

- 1 A. Okay. Six North head. I'm not sure if it's still
- 2 there, but there was one at Five North tail. And
- 3 there's one's at 40 Break. This one is at the Ellis
- 4 Switch. There was one at Ellis Four head, and there's
- 5 one at --- I said Ellis Four head up here, that was
- 6 Four North head. There's one at Ellis Five head. And
- 7 that's all of them. I think there was one at the
- 8 Mother Drive. I know there was. There was one at the
- 9 Mother Drive but I didn't take care of that one. That
- 10 was ---.
- 11 Q. Do you know where it was at, though?
- 12 A. Yes.
- 13 Q. You can mark it, if you want.
- 14 WITNESS MARKS MAP
- 15 BY MR. WATKINS:
- 16 Q. Okay.
- 17 A. Now, there were a couple more on up that I heard
- 18 them talk about, but I don't know their location.
- 19 Q. Spending time at the mine, did anybody ever have
- any complaints that you know of, or voice any
- complaints as far as unsafe conditions at the mine?
- 22 A. Well, not --- not that I know of. Nobody really
- voiced anything over anything unsafe. People complain
- 24 all the time, but I never heard anybody say they were
- afraid to do something or that they felt like they

- 1 were in danger.
- 2 Q. Do you ever remember an occasion where the workers
- may be called off early, or sent home early because of
- 4 the condition at the mines?
- 5 A. We got pulled out one time that I can remember. I
- 6 don't know if they went home early or --- they got
- 7 pulled out one time because of something. I can't ---
- 8 it was an air problem, but they pulled 'em out. That
- 9 one time is all I can remember them ever being pulled
- 10 out. I don't remember exactly when it was, but one
- 11 time's all I can think of.
- 12 Q. About how long ago was that?
- 13 A. It was probably around --- I'm going to say about
- the middle of March, maybe.
- 15 O. Okay. Do you remember which area of the mine was
- 16 affected?
- 17 A. The longwall came out. I don't know what the
- 18 problem was. We had an inspector up there, I know.
- 19 And as I was making my longwall walk, I ran into Tim
- 20 Davis at 78 Break, and he said they're getting ready
- 21 to ---. He said, I think they're getting ready to
- 22 pull us out, we got some air problems. And I said,
- 23 I'm going to walk down my beltline and --- until I see
- 24 somebody, and I walked on outside. When I got
- outside, they were coming out, so ---.

- 1 Q. Did he mention that there was an air reversal
- problem, methane problem or ---?
- 3 A. He said --- I think it was on the tail, something
- 4 with the tail of the longwall. But I don't know --- I
- 5 don't know what the problem was. And I was trying to
- 6 walk down my beltline and get outside before they
- 7 pulled us out.
- 8 Q. That's the only --- that's the only time that you
- 9 remember?
- 10 A. Yeah, that's the only time I can remember being
- 11 pulled out.
- 12 Q. What about Christmas vacations and things like
- that, were they ever cancelled?
- 14 A. Yeah, we worked through vacation. I mean, some of
- 15 'em worked through vacation, longwall worked, and the
- 16 headgate section worked through vacation.
- Q. Did you ever have your vacation cancelled or ---?
- 18 A. Yeah, I worked --- I worked through Thanksqiving
- and, well, Christmas, too. We just took our vacations
- 20 later.
- Q. Just a couple of questions as far as training
- 22 goes. When you first started with UBB, what kind of
- 23 training did you receive with them?
- A. Well, I was ---. At UBB?
- 25 Q. Uh-huh (yes).

- 1 A. Well, I was going to start section bossing and I
- worked with the boss they had up there. I worked with
- 3 him about a week before. And when he left, I took
- 4 over.
- 5 Q. Okay. Where did you receive your experience in
- 6 miner training? When and where did you receive that
- 7 at?
- 8 A. I can't remember.
- 9 EXAMINATION
- 10 BY ATTORNEY BABINGTON:
- 11 Q. Did you get any special training as a fire boss?
- 12 A. No. No, but the job I had before that, I was mine
- 13 rescue. When our mine rescue team went full time, the
- first thing we did for the first quarter was travel to
- all the mines Massey had in West Virginia to do safety
- 16 audits. So I didn't get any special training on how
- to fire boss, but considering the job I had before
- that, I don't really think they thought I needed
- 19 training.
- 20 RE-EXAMINATION
- 21 BY MR. WATKINS:
- Q. You've been in mines that have safety audits.
- What kinds of conditions did they have, are they
- similar to UBB or ---?
- 25 A. Yeah. Yeah, they're similar. I mean, some of

- 'em were --- some of 'em were better and some of 'em
- were a little worse, but I didn't think UBB was as bad
- 3 as what they say. I watch the news, and I hear that,
- 4 and I don't --- I don't know where they're getting
- 5 their information, but I never saw nothing like
- 6 they're talking about on the news, and I worked there
- 7 a year. I was all over that mines and I never saw
- 8 that.
- 9 Q. What kinds of things would you look at during one
- 10 of these audits?
- 11 A. Safety audits, we would go up to a section, check
- their equipment, and make sure they had all their
- safety stuff on their equipment, and make sure they
- were wearing their metacarpal gloves, and had their
- boots on. Wearing their eye protection. And Massey's
- 16 S1 book is as big as a phone book anyway, and we would
- 17 check the stuff that's in the S1 book, and make sure
- 18 their feeder is chained and ---.
- 19 Q. Did you look at the air course and ventilation?
- 20 A. Yeah. We usually --- we usually walked intake
- 21 out. Most of the time we would ride in, and me and
- 22 Shane McPherson usually walked the intake out, almost
- every mine we went in.
- 24 MR. WATKINS:
- 25 I believe that's it.

- 1 ATTORNEY BABINGTON:
- 2 Terry, you got anything?
- 3 MR. FARLEY:
- 4 Nothing.
- 5 ATTORNEY BABINGTON:
- 6 Okay. All right. On behalf of MSHA and
- 7 the Office of Miner's Health Safety, and Training, I
- 8 want to thank you for appearing and answering
- 9 questions today. Your cooperation is very important
- 10 to the investigation as we work to determine the cause
- of the accident. We request that you not discuss your
- 12 testimony with any person aside from your personal
- 13 representative.
- 14 After questioning other witnesses, we may
- 15 call you if we have any follow-up questions that we
- 16 feel we need to ask you. If at any time you have
- 17 additional information regarding the accident that you
- 18 would like to provide to us, please contact us at the
- 19 contact information previously provided.
- 20 If you wish, you may now go back over any
- 21 answer you've given during this interview. You may
- 22 also make any statement you would like to make at this
- 23 time.
- 24 A. Okay. I want to make a statement. I've worked
- 25 for Massey for nine years. And I watch this stuff

- that's going on, on the news, and I hear people talk.
- 2 And I just want to say that I'm a grown man and so is
- 3 everybody else at that mine, and you have a hard time
- 4 to push me to do anything that I don't feel good about
- 5 doing. And I knew all 29 of them men, and I'd hated
- 6 to try to push any of 'em into something they didn't
- 7 want to do. So that's all I got to say.
- 8 I don't --- I don't feel like I've ever been asked
- 9 to do anything unsafe. And if I was, I wouldn't be a
- 10 bit scared to back up and say, I'm not going to do
- that. And, you know, like I said, I've been talked to
- by several people and I've watched the news, and I
- don't --- I don't know where they're getting their
- information, but I didn't see anything like what's
- 15 going on, on the news. Okay. Thank you for letting
- 16 me say what I think.
- 17 MR. WATKINS:
- 18 Of course.
- 19 MR. KINDER:
- 20 No problem.
- 21 MR. FARLEY:
- 22 We appreciate you coming in.
- 23 ATTORNEY BABINGTON:
- 24 Yes. And I want to thank you for your
- 25 cooperation in this matter.
