MEMORANDUM

SUBJECT: Suspended Certification Summary

Since January 1, 2013, two-thousand nine hundred and two (**2902**) individuals have had their mining certifications suspended. Of which two hundred and seventy-seven, (**277**) possessed foreman's certifications; of those, one hundred and forty-six (**146**) were acting as supervisors. Eight hundred and eighty (**880**) individuals' certifications have been suspended due to failed pre-employment drug and alcohol screenings.

Marijuana is the number one item that people are failing for, followed by prescription drugs. One thousand and seventy-six (**1076**) individuals have been reinstated. Sixty-one (**61**) individuals are currently active in a treatment plan. One hundred and sixteen (**116**) people have been permanently revoked for failing a second substance abuse test.

Over one-thousand four hundred, (**1,400**) individuals are currently suspended or have not requested to be reinstated after serving their 3-year suspension from coal mining. There have been two hundred and sixty-three (**263**) no actions taken, for various reasons, (i.e., out of state workers, no West Virginia certifications,) etc.

Three-hundred and fifty (**350**) individuals have had their safety sensitive cards temporarily suspended due to failure of the substance abuse urine test given by the employer.
