### EMT 1<sup>st</sup> and 2<sup>nd</sup> Response Kit *Minimum* Requirements

Chapter 22A, Article 10 – 1(b) The emergency medical services personnel must be employed at their regular duties at a central location, or when more than one person is required pursuant to the provisions of subsection (d) of this section, at a location which provides for convenient, quick response to an emergency. The emergency medical services personnel must have available to them at all times such equipment prescribed by the Director of the Office of Miners' Health, Safety and Training, in consultation with the Commissioner of the Bureau for Public Health.

1	1	BSI equipment (Gloves various sizes, Glasses, Bloodborne Pathogen Response Kit, etc.)
2	4	Oropharyngeal airways, assorted adult sizes
3	4	Nasopharyngeal airways, assorted adult sizes
4	1	Water Base Lubricant for nasopharyngeal airways
5	1	Mouth to mask resuscitation device, with oxygen inlet or valve mask
6	2	Large sterile universal trauma dressings
7	24	Sterile gauze sponges, individually wrapped 4" x 4"
8	1	Military grade tourniquet
9	2	Rolls, adhesive tape, 3" x 10 yds.
10	1	Bandage scissors 7 1/2"
11	1	Bite stick
12	4	Sterile ABD dressing, 5" x 9" or equal
13	6	Soft roller bandages, self-adhering, 4" x 5 yds.
14	4	Soft roller bandages, self-adhering, 6" x 5 yds.
15	2	Occlusive dressings, 2" x 3" with adhesive strip
16	6	Various sizes of hemostatic dressings
17	1	Blood pressure cuff (aneroid sphygmomanometer)
18	1	Stethoscope (diaphragm head)
19	1	Portable suction unit with large bore tip
20	1	Portable oxygen unit; pressure gauge; flowmeter indicator (adjustable 2-15 lpm); 300 liter ("D") cylinder or equal; delivery tube; non-rebreather mask and nasal cannula
21	1	Bag valve mask
22	1	Half-ring lower extremity splint with commercial limb-support slings, padded ankle hitch and traction apparatus or equivalent i.e. Kendrick traction splint
23	3	Hard cervical collars, assorted adult sizes or one locking type adjustable cervical collar
24	12	Safety pins, large
25	2	Sterile sheets, disposable for burns
26	1	Sterile water, 1,000 ml
27	1	KED or equivalent

Item numbers 1-16 (inclusive) are required in a 1<sup>st</sup> response kit, and item numbers 1-27 (inclusive) are required in a 2<sup>nd</sup> response kit
